1.0 NTPC invites GeM bids on Single stage two envelope basis for aforesaid Package, as per the Brief Scope of Work mentioned hereinafter.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects Class-I local suppliers only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

2.0 The Bidding Documents for the aforesaid package has been uploaded on GeM Portal https://gem.gov.in and may be downloaded through the same.

3.0 BRIEF SCOPE OF WORK

The scope shall include Consultancy and Engineering Services for preparation of DPR with a single point responsibility which includes Pre-DPR Stage Clearances and DPR Stage Clearances, Survey and Investigations. The consultant will be required to work with NTPC for successful completion of all activities as required. Around 95 Acres of land is identified for installation of power plant in multiple phases with various offsite facilities. The minimum area needs to be used for the installation of the power plant as per the requirement described for the present DPR and balance space to be assigned for required future expansion. The scope of work mentioned hereunder is only an indicative and not exhaustive. The

selected bidder shall in a time bound manner carryout all studies, designs and other required works required for completion of the Detailed Project Reports in full shape as per latest CEA guidelines, standards, etc. and obligations enshrined in this document, unless specifically excluded.

The detailed scope of work shall be as per scope defined in the Vol-II, TOR of Bidding Document No. CS-6401-714-9.

- **4.0** NTPC intends to finance the subject package through Own Resources.
- **5.0** Dates for Bid Submission and Opening shall be as displayed in the GeM Bid.
- All bids must be accompanied by Bid Security for an amount of INR 2,00,000/(Rupees TWO Lakh only). The Bid Security shall, at the Bidder's option, be in the
 form of Electronic Fund Transfer (EFT)/ irrevocable Letter of Credit or a bank
 guarantee from any of the banks specified in the Bid Data Sheets or an Insurance
 Surety Bond from an Insurer as per guidelines issued by Insurance Regulatory
 and Development Authority of India (IRDAI).

"The format of the Bank Guarantee shall be in accordance with the form of Bank Guarantee towards Bid Security/EMD/Performance security//*Advance payment (if applicable) included in the Employer's Bidding Documents only. In addition, the format of the Insurance Surety Bond shall also be in accordance with the form of Insurance Surety Bond towards Bid security/Performance security/included in the Employer's Bidding Documents only. Any bid not accompanied by an acceptable bid security in a separate sealed envelope shall be rejected by the Employer as being non-responsive.

"Any bid not accompanied by an acceptable bid security in a separate sealed envelope shall be rejected by the Employer as being non-responsive. IN CASE, THE BID SECURITY IS SUBMITTED THROUGH ELECTRONIC FUND TRANSFER (EFT), BIDDER TO SUBMIT THE PROOF OF E- PAYMENT OF BID SECURITY EITHER IN SEPARATE SEALED ENVELOPE OR IN THE GeM PORTAL."

HOWEVER, MSEs* SHALL BE EXEMPTED FROM PAYING BID SECURITY.

*Micro and Small Enterprises (MSEs) registered with Udyam Registration Portal as per MSMED Act 2006 for goods produced and services shall be eligible for MSE benefits. Applicable relevant MSME Certificate should be submitted online/offline before schedule bid submission end date & time.

It is advised that all the Prospective Bidders shall register and obtain Udyam Registration Certificate. It may be noted that w.e.f. 1st April 2022, Udyam Registration Certificate shall be only valid Certificate to avail the benefits as per Public Procurement Policy. MSEs seeking exemption and benefits should enclose an attested/self-certified copy of Udyam registration certificate as a part of his bid, giving details such as stores/services, validity (if applicable) etc. failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.

Further, the bid security exemptions as provided by GeM shall also govern.
