**2.0 BRIEF SCOPE OF WORK**

Mobile Health Clinic (MHC) and Maternal and Child Health Care services for project affected villages - NTPC Barh for a period of Four years.

NTPC intends to finance subject Package through Domestic Commercial Borrowings/Own sources.

4.0 All bids must be accompanied by Tender Fees (Cost of Bidding Documents) and Bid Security.

5.0 Online payment option for Tender Fee and Bid Security is made available at GePNIC portal. Bidders are requested to please avail the facility.

**ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE TENDER FEE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.**

6.0 **Benefits to MSE bidders are applicable for this work.** The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

7.0 A complete set of Bidding Document may be downloaded by any interested Bidder from <https://eprocurementpc.nic.in/nicgep/app>. Tender fee (in case of offline payment) as mentioned above is required to be submitted in separately sealed envelope at the address mentioned in the bidding document before stipulated date & time of submission of bid.

**Prospective bidders are compulsorily required to provide GSTIN number with Tender Fee.**

## **8.0 QUALIFYING REQUIREMENTS FOR BIDDERS.**

**The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfill the following Qualifying Requirements:**

### **8.1 Technical Criteria**

*1.1 The bidder should have executed the work of deployment of “Mobile Health Clinic” as per following within the preceding seven (7) years reckoned as on the date of Techno-Commercial bid opening:*

*a) One order of value not less than Rs. 31.88 Lakhs.*

*OR*

*b) Two orders of value not less than Rs. 19.92 Lakhs each.*

*OR*

c) *Three orders of value not less than Rs. 15.94 Lakhs each.*

*Notes:*

*1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.*

*2. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.*

*3. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.*

*4. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break – up of basic value and taxes.*

## **7.2 Financial Criteria:**

*7.2.1 The Average Annual Financial Turnover (AATO) of the bidder during preceding three (03) consecutive financial years as on the date of Techno -Commercial bid opening should not be less than **Rs. 39.85 Lakhs.***

*7.2.2 In case the Bidder does not satisfy the financial criteria, stipulated at Cl. No. 2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. No. 2.1 above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the Bidder would be required to furnish along with its TechnoCommercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the Bid Documents, pledging unconditional & irrevocable financial support for the execution of the contract by the bidder in case of award.*

*7.2.3 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:*

*Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.*

*A certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Financial Statements of the Holding Company..*

*7.2.4 In cases where audited results for the last financial year as on the date of Techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three (03) consecutive financial years preceding*

*the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding document stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying financial parameters is not available.*

**Notes for 7.2:**

1. *Net worth means the sum total of the paid-up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.*
2. *Other income shall not be considered for arriving at annual turnover figures.*
3. *“Holding Company” and “Subsidiary Company” shall have the meaning ascribed to them as per Companies Act of India, in vogue. 4. Financial figures are rounded off to nearest whole number in lakh.*

*NOTE: Bidders should submit the details of the reference works and financial data in format (Attachment 3) available in Section VIII (Forms).*

**9.0** **~~‘Class-I local suppliers’/ ‘Class-I local suppliers and Class-II local suppliers’~~** only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

OR

~~Bids from ‘Class-I local suppliers’ as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT shall be eligible for purchase preference. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."~~

**10.0** Any ‘Bidder from a country which shares a land border with India’, as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

**11.0** NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.

12.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.

13.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
