- b) Rfx will be available to view for all the bidders which are already having valid SRM User ID's.
- c) Interested bidders have to register first against the Bid invitation by clicking on "Register" button placed into Rfx header segment.
- d) Tender document fee should be submitted on line/offline (Demand Draft / Pay Order / Banker's Cheque only except exemption document and EMD also may be submitted online/offline.
- e) Once Registration step & Tender fee submission is done by bidder and the tender fee received by the NSPCL and updated into the system then Bidder could be able to "Create Response" and submit the bids against the Bid invitation into the system.
- 3. New Bidders which are not having SAP/ERP Vendor Code and or SRM User ID:

# **QUALIFYING REQUIREMENT**

Name of Works: "BIENNIAL MAINTENANCE CONTRACT OF ELECTRICAL ,ECR, LIGHTING EQUIPMENT, DAETP , SOLAR & MISC JOB, O/H & MAINTENANCE OF HOIST & O/H OF OFF-SITE HT/LT SWITCHGEAR OF EMD NSPCL-DURGAPUR."

## **1.0 FINANCIAL CRITERIA:**

**1.1 Turnover**: The Average Annual Turnover of the Bidder, in the preceding three (03) financial years, as on date of bid opening should not be less than **Rs. 141.59** Lakhs (Rupees One forty one lakhs fifty nine Thousand only).

## 2.0 TECHNICAL CRITERIA:

- **2.1** The bidder must have valid electrical contractor licence in name of the person or firm & a valid supervisor certificate of competency up to 33 KV jobs undertaken by such person or firm.
- **2.2** The bidder must have experience in successfully executing similar works within preceding 7 (seven) years as on date of technical bid opening, having executed value under-
  - (a) Single Order of value not less than Rs. 113.27 Lakhs/- (Inclusive of taxes & duties).

OR

(b) Two Orders each of value not less than Rs. 70.79 Lakhs/- (Inclusive of taxes & duties).

OR

(C) Three Orders each of value not less than Rs. 56.63 Lakhs/- (Inclusive of taxes & duties).

#### NOTE:

- 1. The Word "Executed" means that the bidder should have achieved the progress specified in the QR para 2.2 even if total contract/order is not completed/ closed. The same shall be supported by documentary evidence issued by the owner/ employer such as Completion Certificate/ Joint protocol / copy of Final Bills etc.
- 2. The Word "Similar Work" means Overhauling or Maintenance or Erection of following Electrical systems in any of the PSU or it Joint venture company/Govt. or Semi Govt. Department /SEB/ Public Limited company/Private Ltd. Company.
  - a) Any combination of Electrical system comprising of "HT switchgear / Panels" and "33 KV or above rated switchyard Equipment/ Bays"

OR

- b) "33 KV or above" rated switchyard Equipment/ Bays.
- 3. For Financial selection Criteria, QR para 1.0, Bidder must submit copy of Audited Balance Sheet and Profit & Loss Account for the specified period. In case, where audited results for the Last Financial year as on the date of technical bid opening, are not available, the Financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from the practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year, shall be considered for evaluating the financial parameters.
- 4. Other Income shall not be considered for arriving at annual turnover.
- 5. Necessary documentary evidence in support of the above criteria of QR to be furnished by the bidder.

## **NIT Conditions**

- 1. Bid documents will be issued to all the parties on their request (cost of tender document to be made by a crossed demand draft / pay order / banker's cheque in favour of NTPC SAIL POWER COMPANY LIMITED payable at Bhilai) for issue of bid documents without prima-facie examination of their qualification status. However, issue of bid documents shall not mean that bidders are considered qualified. Tender document fee will not be refunded. Request for tender documents received after the last date as mentioned above due to delays postal/courier services shall not be entertained.
- 2. NSPCL reserves the right to reject any or all bids or cancel / withdraw the Invitation for bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 3. Agencies are advised to visit the site to familiarize themselves with the nature of work and the site conditions.
- 4. If the last date of receiving application and date of bid opening coincide with a holiday, the date will be shifted to the next working day.
- 5. Micro and Small Enterprises (MSEs) registered with Udyam as specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit & shall be issued the bidding documents free of cost and shall be exempted from payment of Tender Fee.
