#### <u>Expression of Interest for Artificial Intelligence Based Conversational Knowledge</u> Management Platform

- 1.0 NTPC is India's largest power utility with installed capacity of more than 71,000 MW (including its JVs). The company is engaged in the business of generation and sale of bulk power. NTPC is having pan-India presence with own stations coal based, gas based, Hydro, Wind and Solar plants. Established in 1975, NTPC has forayed into diverse arena like coal mining and green hydrogen also.
- 2.0 NTPC leverages technology in its internal and external operation to increase competitive advantage & profitability. Development of Artificial Intelligence Based Conversational Knowledge Management Platform will help in capturing experiential knowledge from credible sources avoiding AI hallucination, providing for wider dissemination avoiding unauthorized use through password protection and retrieval of knowledge in the format sought by the employee.
  - 3.0 The primary objective is to make information and contents related to NTPC Ltd. open and accessible to all employees. The Conversational AI Bot (Chat & Voice) on Knowledge Management website of NTPC Ltd. is a step in this direction. The Bot is expected to aid with technical information, experiential knowledge within NTPC including (but not limited to) providing information on employees, project details, work information flow across the organization and making every information knowledge gained with equipment and troubleshooting solutions for various system or sub-system of thermal power station/unit and extend design and engineering support for the same with a few clicks. The platform is expected to serve the familiarization and training requirements of new entrants to a division and provide for their competency and proficiency mapping. Further, to veteran employees of chosen it would ask relevant questions starting with a year in advance to capture their competency on the platform.
- 4.0 In furtherance to the above, NTPC has decided to take up the work for Artificial Intelligence Based Conversational Knowledge Management Platform with all desired features and capabilities as mentioned in this document to:

**Build** sophisticated, intelligent, and interactive bot (Chat and Voice) capable of carrying out complex queries and produce accurate responses providing seamless experience throughout the entire user journey.

**Deploy the Bot** over multiple channels (Website & Mobile App-iOS & Android), in English.

**Collect** conversational data from user queries & feedbacks and use it to train and personalize the conversational AI Bot as a continuous process. The trained AI model shall be owned by the Engineering Division of NTPC Ltd. and may not be used anywhere else without consent of NTPC Ltd.

Integrate with various knowledge sources (Departments, Divisions and Sections of NTPC) and fetch

relevant information for responding to user queries.

**Provide Platform Analytics Module** to generate reports and leverage the usage data for continuous improvements and **present** the data on a dashboard.

- 5.0 Through this section, NTPC invites willing APPLICANTS from India who can provide with broad requirements for AI Based conversational Knowledge Management System, providing for
  - 1. AI/ML based solution.
  - 2. English language.
  - 3. It Should be able to get information from NTPC Intranet, web pages, e mails, documents, conversations (with permission), images, time series data including IIOT and database tables. These will be the main data sources. It should have features of NLP (Natural Language processing), deep learning and cognitive computing.
  - 4. It shall have Self-learning capability in case of unanswered questions.
  - 5. It Should be capable enough to update with latest answer (if desired answer is getting changed over the period)
  - 6. It must Report un-answered questions.
  - 7. The platform is expected to serve the familiarization and training requirements of new entrants to a division and provide for their competency and proficiency mapping.
  - 8. Further, to veteran employees chosen it would ask relevant questions starting with a year in advance to capture their competency on the platform.
  - 9. The solution shall allow easy incorporation of possible future changes/modifications in KMS or changes in the documents etc., that may take place in future.
