The Brief scope of work under this Consultancy Assignment is as under:

#General review and comments on tender documents from Legal perspective;

#Providing legal advice on Company Laws, Investment law, labor law, Electricity Laws, Grid code, Environmental and social Laws and other prospective local laws of Uzbekistan for a Solar PV based power project developer & operator and for a Power Transmission Line, which is relevant to this project;

#General review of Project Specific Agreements or clauses on which such agreements shall be based;

#Providing advice on taxation related issues (corporate income tax, tax on dividends, other direct taxes, Custom, safeguard duty/countervailing duty/any other duty on solar panels and balance of plant, GST, VAT, service tax and other Indirect taxes), BIPA, DTAA, currency conversions, Currency convertibility, Repatriation, FEMA available financing options etc. for setting up Solar PV based power project developer & operator and a Power Transmission Line in Uzbekistan;

#Advise on Legal, Capital gains tax on transfer of project and financial aspects of transfer of Project to National Electricity Grid of Uzbekistan (NEGU) on the 25th anniversary of the Project's Commercial Operation Date or as per RFP terms;

#Assistance of local attorney in Uzbekistan for completing legal formalities of bidding;

#Advise on Legal, Financial and taxation aspects of decommissioning of the Project as per the project agreements;

#Review of E&HS standard and other standards mentioned in the project agreements;

#Review and advise on all documents to be submitted by NTPC and its consortium partner as required as a part of the bid proposal and as directed by NTPC representative / EIC for this contract.
