4.0 Brief Scope of Work and other Specific details:

Operation & Maintenance of Water Supply & RO Water System installed at NTPC-PMI, Sector-16A, Noida for a period of 02 years. The Scope of work includes operation and maintenance of existing drinking water supply system, RO water system including drinking water pump house by deployment of manpower, all required T&P, repair and maintenance of all pumps and motors and supply of various materials as per BOQ etc. for interruption free water supply at PMI.

5.0 Downloading / Issuance of bidding documents to any bidder shall not construe that bidder is considered qualified.

6.0 Qualifying Requirements for Bidders:

- 6.1 The bidder should have successfully executed any one of the following works in preceding seven (07) years as on the date of techno-commercial bid opening, which includes Operation and Maintenance of either Water Supply system and/or RO Water system and/or Water Treatment plant, in India:
 - a) One completed / executed work having executed value not less than **Rs.19,29,700.00**.

OR

b) Two completed / executed works having executed value not less than **Rs.12,06,000.00** each

OR

c) Three completed / executed works having executed value not less than **Rs.9,64,900.00** each

The work "**executed**" means the bidder should have achieved the criteria specified in the QR, even if the total contract is not completed / closed.

In case of contracts under execution as on date of bid opening, the value of work completed till the date of bid opening will be considered provided the value of executed work is certified by the employer.

6.2 The average annual turnover of the bidder, in the preceding three (03) financial years as on the date of Techno-Commercial bid opening shall not be less than **Rs.24,12,100.00** (Rupees Twenty-Four Lakhs Twelve Thousand One Hundred only).

Note:

- While computing the turnover other income shall not be considered.
- In cases where audited results for the last financial year as on the date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
- **7.0** 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents. However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

8.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Notice Inviting Tender [NIT] for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
