Design, engineering, manufacturing, supply, inspection & testing, packing, forwarding to site, unloading, dismantling/relocation, pre-assembly/ assembly, civil/structure work, erection, supervision, pre-commissioning, trial operation, testing and commissioning and performance testing of the equipment/system and works under the package scope

Supply, Erection & Commissioning of Separation of process water & storm water drain along with Zero Liquid Discharge at VSTPS

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

Bidders are requested to give acceptance of meeting the MLC (Minimum Local Content) requirement by accepting the GTE & declaration as per Annexure-III to BDS.

By accepting the MLC provision of GTE it will be considered that:-

"Bidder is 'Class-I local supplier' and is meeting the MLC requirement stipulated in Annexure-II to BDS.

Also supplier has not been debarred / banned by any other procuring entity for violation of 'Public Procurement (Preference to Make In India), Order 2017' (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)".

In case false declaration in respect of Local content, same shall be treated as false declaration and will be dealt in line with the Fraud Prevention Policy of NTPC.

4.1 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India

has extended lines of credit or in which the Government of India is engaged in development projects.

- 5. Bidder has to ensure the following documents to be submitted offline and the same should reach in sealed envelopes before the bid submission deadline prescribed by the Employer, pursuant to ITB Clause 16, failing which bid is liable for rejection
  - 5.1 Tender Fee: as applicable
  - 5.2 Earnest Money Deposit : as applicable
  - 5.3 Integrity Pact: Applicable

Any bid not accompanied by an acceptable Earnest Money Deposit, Tender fees and/or Integrity pact (If applicable) shall be rejected by the Employer as being non-responsive and shall be rejected without being opened.

# 6. Qualifying Requirements for Bidders:

# 6.1.0 <u>Technical Criteria</u>

The bidder should have supplied, erected/supervised erection and commissioned /supervised commissioning of at least one (1) number of 'water / waste water 'pumping plant or treatment plant 'having capacity of not less than 850m³/hr including or excluding civil work. The plant should have been in successful operation for at least one (01) year prior to the date of Techno-commercial bid opening.

#### Notes for Clause 6.1.0 above:

(i) The word "executed" means the Bidder should have achieved the criteria specified in the qualifying requirements at Clause 6.1.0, even if the contract has been started earlier and/or is not completed/ closed and shall be considered as below.

Case-I: The work is started earlier prior to the period stipulated in Clause-6.1.0, but completed within the stipulated period as mentioned in clause 6.1.0. In such cases, entire executed value of the relevant work vide that work order shall be considered for evaluation.

Case-II: The work is started and completed within the stipulated period as mentioned in clause 6.1.0

Case-III: The work is started within the stipulated period as mentioned in clause 6.1.0 but not completed as on the last date of stipulated period. In such cases, "In Progress" executed value of the relevant work vide that work order as on the last date of stipulated period, shall be considered for evaluation.

(ii) Remarks: Any of the above cases shall be supported by documentary evidence issued by the "Owner". "Owner" means the entity which has the original requirement of the subject work and has initiated and awarded the work to the contractor (bidder) for executing the reference work against which the credentials have been submitted.

And the "Owner" defined as above is not a contractor to any other entity for the reference work. In

case, the bidder has worked as approved sub-Contractor/sub-vendor, he has to provide documentary evidence issued by the "Owner".

## **6.2.0 Financial Criteria:**

**6.2.1** The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, should not be less than Rs 2241.77 Lakhs (Rupees Twenty Two Crore Forty One Lakhs and Seventy Seven Thousand only).

In case a bidder does not satisfy the financial criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.

**6.2.2** The Net Worth of the bidder as on the last day of the preceding financial year (reckoned on the date of techno-commercial bid opening) should not be less than 100% of the Bidder's paid-up share capital. In case the Bidder meets the requirement of Net worth based on the strength of its Subsidiary (ies) and/or Holding Company and/or Subsidiaries of its Holding companies wherever applicable, the Net worth of the Bidder and its subsidiary (ies) and/or Holding Company and/or subsidiary (ies) of the Holding Company, in combined manner should not be less than 100% of their total paid-up share capital. However individually, their Net worth should not be less than 75% of their respective paid-up share capitals.

Net worth in combined manner shall be calculated as follows:

Net worth (combined) = (Xl+X2+X3) / (Y1+Y2+Y3) X 100Where XI, X2, X3 are individual Net worth which should not be less than 75% of the respective paid up share capitals and YI, Y2, Y3 are individual paid up share capitals.

- **6.2.3** In case the bidder is not able to furnish its audited financial statements on stand alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:
- Copies of the unaudited unconsolidated financial statements of the bidder along with copies (a) of the audited consolidated financial statements of its Holding Company.
- A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated annual financial statements of the Holding Company.

In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format

enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### NOTES for clauses 6.2.0 and 6.3.0 above:

- (i) Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- (ii) Other income shall not be considered for arriving at annual turnover.
- (iii) "Holding Company" and "Subsidiary" shall have the meaning ascribed to them as per Companies Act of India
- 7. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators / associates/ subsidiaries/ group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
- 8. Employer reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 9. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.
