3.0 Qualifying Requirements of Bidders:

	ii) A certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Financial Statements of the Holding Company.
3.3	In cases where audited results for the last financial year as on the date of Techno-commercial bid opening are not available , the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three (03) consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
	Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding document stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying financial parameters is not available.
3.4	Clarificatory Notes for the Clauses above:

	 II. Bidder should submit documentary evidence issued by the owner, in support of having met the Qualifying requirements, alongwith their Technical offer. These documentary evidence may include: Relevant Purchase Orders/ Work Orders copies. Work Completion & Performance Certificate against submitted Purchase Orders / Work Orders from the End user
	III. In case of composite work/ BOQ, the bidder shall have to furnish Certificate from owner certifying the value of specific nature of work, as mentioned in Clause 1.0.

IV. Reference work executed by bidder as a sub-contractor may also be considered provided the certificate issued by the main contractor is duly certified by the Project Authority specifying the work executed by the subcontractor in support of the qualifying requirements.

V. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.

VI. Other income shall not be considered for arriving at annual turnover figures.

VII. For Annual Turnover indicated in foreign currency, the exchange rate as on seven (07) days prior to the date of techno-commercial bid opening shall be used.

VIII. All Financial **figures** mentioned above are **exclusive of GST**.

4.0 SUBMISSION OF BIDS:

Documents to be submitted offline: Tender fee, Bid security declaration in lieu of EMD, NIL deviation certificate, Local Content Declaration are to be submitted online in respective folder within the specified bid submission date and time in GePNIC portal. Due to spread out of COVID-19 submission of hard copy of tender documents or any other documents may be avoided.

IMPORTANT NOTE: Any Bid not accompanied by above mentioned 03 documents (viz i) acceptable Tender fee, ii) acceptable Bid Security declaration, iii) acceptable NIL deviation certificate/GTE acceptance and iv) Local Content Declaration along with their e-bid shall be rejected by the Employer/NTPC Ltd as being non-responsive bid.

Note: Because of Overall evaluation, splitting is not allowed.

Exemptions for Tender fees:

Udyam Registration Certificate ,Micro and Small Enterprises (MSEs) registered with District Industries Centres or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts or Udyog Aadhar registered vendor and Handloom or any other body specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Tender fees.

If the validity of the certificate (if applicable) has expired then run the risk of their tenders being passed over as ineligible for this concession /exemption.

In case of any doubt on eligibility of such exemption/concession, bidder may get clarification from NTPC official before submission of their bid.

The Bid Security of all the unsuccessful Bidders will be returned after award of the Job.

5. 0 TECHNO COMMERCIAL BID:

Techno Commercial bid is to be submitted in the e-procurement portal of NTPC (GePNIC). It is suggested that the bidder may fill the techno commercial bid well in advance to avoid last minute problems/rush in the system.

Techno Commercial bid is to be filled online after carefully examining the documents / conditions and the schedule of work. All the prices are to be filled in at the relevant fields in attached BOQ Excel sheet. Bidder shall also upload all the required documents as required *including* scanned copy of *i*) *Tender fee, ii*) *Bid Security Declaration, iii*) *Power of Attorney, iv*) *Local Content Declaration v*) *NIL deviation certificate* in relevant folder online.
