2.0	<p><u>FINANCIAL CRITERIA:</u></p> <p>Average Annual Turn Over: The average annual turnover of the Bidder, in the preceding three (03) consecutive financial years as on the date of Techno-Commercial bid opening, should not be less than Rs. 119.00 Lakhs (INR One Hundred and Nineteen Lakhs only).</p>
3.1	<p>In case a Bidder does not satisfy the annual turnover criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements as above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid- up share capital of the Holding Company. 4.0 SUBMISSION OF BIDS:

TECHNO COMMERCIAL BID:

Techno Commercial bid is to be submitted in the e-procurement portal of NTPC(GePNIC). It is suggested that the bidder may fill the techno commercial bid well in advance to avoid last minute problems/rush in the system.

Techno Commercial bid is to be filled online after carefully examining the documents / conditions and the schedule of work. All the prices are to be filled in at the relevant fields in attached BOQ Excel sheet.

- 5.0 NTPC reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids (IFB) for the subject package without assigning any reason; whatsoever, and in such case no bidder/intending bidder shall have any claim arising out of such action.
- 6.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified.
- 7.0 Transfer of Bidding Documents purchased by one intending bidder to another is not permissible.

8.0 A complete set of Bidding Documents may be downloaded by any interested bidder directly through NTPC e-procurement portal, <https://eprocurentpc.nic.in>.

9.0. Procedure of bid opening: For submission of bids, the time and scheduled Bid Submission Date shall be treated as cut-off line, and accordingly, the bids shall be frozen. The tender Committee or their authorised representatives shall open the Technical bid and evaluation shall be done. If the scheduled Bid Opening Date happens to be a closed holiday, the next working day shall be treated as Bid Opening Date.
