NTPC shall purchase the solar power generated from subject project at initial tariff of INR 1.91/kWh for the first contract year, and that will be escalated at a rate of 01 (one) paisa/kWh per year till the period of 25<sup>th</sup> year. The duration of PPA shall be 25 year from effective date of PPA.
