1.0 NTPC Limited (NTPC) invites online bids on "Single Stage Two Envelope Bidding basis" from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

2.0 BRIEF SCOPE OF WORK

The scope of work under this contract shall include providing manpower, complete materials (cement, paint etc.), T&P that are required for External painting works of township in Ph-I & Ph-II which includes 180 nos. Quarters and public building like Shopping Centre, Swimming pool, Hospital, AB Hostel Chetak Club and external painting of Overhead tank. As per direction of EIC including repairing of structure if required before painting as per direction of EIC in the residential and public buildings in Ph-I & Ph-II Township, and any area / premises to be decided by the EIC at Anta Gas power station.

- 3.0 NTPC intends to finance subject Package through Domestic Commercial Borrowings/Own sources.

All bids must be accompanied by **Bid Security Declaration**. Bid Security Declaration shall be submitted by accepting the General Technical Evaluation (GTE) in Online Portal in accordance with ITB Clause 14.

In case a bidder does not accept the aforesaid declaration in GTE, then the bid shall be rejected by employer as being non-responsive and shall not be opened.

ANY BID NOT ACCOMPANIED BY TENDER FEE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

5.0 ONLINE SUBMISSION TENDER FEE

The facility of submitting Tender fee through ONLINE MODE has been made available at Gepnic portal for NTPC. Bidders who wish to use this facility can avail the same in the e-procurement portal (Gepnic portal). Bidders availing this facility, are NOT required to submit documents of tender fee physically (hardcopy).

6.0 Benefits of MSE bidders in respect of Tender Fee, Bid Security and purchase preference are NOT applicable in this case.

7.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

7.1 Technical Criteria:

- 7.1.1 The bidder should have executed similar work/s within preceding 07 (seven) years reckoned as on the date of Techno-commercial bid opening in any of the following manner:
- a. One (1) order having executed value not less than INR 45 Lakh

OR

b. Two (2) orders having executed value not less than INR 28 Lakh each

OR

c. Three (3) orders having executed value not less than INR 22 Lakh each.

Note:

- 1. "Similar work/s" means: 'Painting of Buildings/Structures' AND/OR 'Civil construction/Civil maintenance works including painting.'
- 2. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 3. In case of orders under execution, the value of work executed till the date of Techno-commercial bid opening duly certified by owner shall be considered acceptable.
- 4. Reference work executed by the bidder as a sub-contractor may also be considered provided that certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

7.2 Financial criteria:

- **7.2.1** The average annual turnover of the bidder should not be less than INR 56 Lakh(Rupees Fifty Six Lakh only) during the preceding three (3) completed financial years as on the date of Techno-commercial bid opening.
- **7.2.2** In case the bidder does not satisfy the financial criteria, stipulated at Cl. 7.2.1 above on its own, its holding company would be required to meet the stipulated turnover requirements at Cl. 7.2.1 above, provided that the net worth of such holding company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the holding company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the holding company, supported by Board Resolution of the holding company, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- **7.2.3** In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
- **1.0** Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.
- **2.0** A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements of the bidder form part of the audited Consolidated Annual Report of the Holding Company.
- **7.2.4** In cases where audited results for the last preceding financial year as on the date of technocommercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.

Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Technocommercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

NOTES:

- 1.0 Other income shall not be considered for arriving at annual turnover.
- 2.0 "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- 8.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.
- 9.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 10.0 A complete set of Bidding Document may be downloaded by any interested Bidder from https://eprocurentpc.nic.in/nicgep/app. Tender fee as mentioned above in the form of a crossed account Payee demand draft in favor of NTPC Ltd., Payable at KAWAS is required to be submitted in separately sealed envelope at the address mentioned in the bidding document before stipulated date & time of submission of bid.

Prospective bidders are compulsorily required to provide GSTIN number with Tender Fee.

- 11.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening. Bidder shall furnish Cost of bidding document, Bid Security and Power of Attorney separately offline as detailed in Bidding Documents by the stipulated bid submission closing date and time at the address given below.
- 12.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- 13.0 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

OR

'Class I local suppliers' and 'Class II local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

OR

"Bids from 'Class I local supplier' as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT shall be eligible for purchase preference. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."
