The Bidder would be required to register in the website. First time users are required to register themselves on NTPC tender website after filling up the required details. Users whose email address has not been linked to a vendor code allotted by NTPC/ first time users not allotted any vendor code by NTPC, should send a copy of the registration details to the e-mail address specified in this NIT under Address for Communication with following details at least three working days prior to Technical Opening Date:

**5.0 Brief Scope of Work & other specific detail**

The Bidder's scope of work includes supply, installation and related services and configuration for all Equipment's, and application as per technical specifications for implementation infrastructure Wi-Fi setup (IWF setup) at NTPC Ltd at NTPC's scope complex office.

The Bidder shall be responsible for dismantling of the existing PACs, Installation of New PACs and providing all material, equipment and spares as covered in technical specifications.

**6.0 Qualifying Requirements for Bidders:**

- 6.1 The bidder should be a manufacturer or subsidiary of manufacturer or a group company of manufacturer (representing manufacturer in India), of WiFi and switches for network.

OR

The bidder should be partner /dealer / system integrator of above and should be authorized by them for this tender

- 6.2 The bidder should have executed any one of the following work which includes supply & installation of Network Equipment (Switch and Wi-Fi system that includes Wireless controller, NAC and Access points) in India in the preceding 7 (seven) Years as on the date of TechnoCommercial bid opening:
- a. One executed work having value not less than Rs. 440.00 Lakh

OR

- b. Two executed works having value not less than Rs. 275.00 Lakh each.

OR

- c. Three executed works having value not less than Rs 220.00 Lakh each.

1. The word “executed” means the bidder should have achieved the criteria specified even if the total contract is not completed/closed. However, the supply & installation of Network Equipment (Switch and Wi-Fi system that includes Wireless controller, NAC and Access points) must be included in the work executed as per client certificate.

2. In case of work under execution, the value of work executed till the date of techno-commercial bid opening as certified by the client shall be considered. However, supply & installation of Network Equipment (Switch and Wi-Fi system that includes Wireless controller, NAC and Access points) must be included in the work executed as per client certificate.

6.3 The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of techno-commercial bid opening, should not be less than Rs. 384.00 lakh (Rupees three hundred Eighty Four lakh only).

NOTE:

3.1) While computing the turnover, other income shall not be considered.

3.2) In case, where audited results for the last preceding financial year are not available, certification of financial statements from a practicing Chartered Accountant shall be considered acceptable.

3.3) In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.

Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of techno commercial bid opening and the certificate from the practicing Chartered Account certifying the financial parameters is not available

**7.0 Issuance of Bidding Documents to any bidder shall not construe that bidder is considered qualified.**

**8.0 NTPC shall allow purchase preference to MSEs and local suppliers as defined in the bidding documents. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.**

**9.0** NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
