1. Note:

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

NOTE:

Bidders are requested to give acceptance of meeting the MLC (Minimum Local Content as 50%) requirement by accepting the GTE & declaration vide Bid Form.

By accepting the MLC provision of GTE it will be considered that:-

“Bidder is 'Class-I local supplier’ and is meeting the MLC requirement stipulated in **Annexure- II to BDS.**

Also supplier has not been debarred / banned by any other procuring entity for violation of ‘Public Procurement (Preference to Make In India), Order 2017’ (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)”.

In case false declaration in respect of Local content, same shall be treated as false declaration and will be dealt in line with the Fraud Prevention Policy of NTPC.

No further claim in this regard shall be entertained by the Employer.

4. Clarification on bidding documents:

A prospective Bidder requiring any clarification of the Bidding Document shall put the query under Clarification tab of the on-line bid at least three days prior to the clarification end date. EMPLOYER will respond to any request for clarification or modification of the bidding documents that it receives within the time line specified.

5. Qualifying requirement:

1.0 Technical Criteria

1.1 Bidder should have **Designed, Manufactured, Supplied, Installed and Commissioned “Cable Drag System/Energy Chain System”** at least at two different locations for “Stacker reclaimer / Plough feeder/ Movable tripper”, out of which at least one system should have been in successful operation for one year:

1.2 Bidder should have **Designed, Manufactured, Supplied, Installed and Commissioned** at least one (01) Nos. of **“Cable drag system/Energy Chain System for 415V”** and above.

1.3 Bidder should have executed the works of Design, Supply, Erection and commissioning of “Cable drag system/Energy Chain System” in the preceding seven (07) years prior to Techno commercial bid opening date meeting the following criteria:

(i) Single order of value not less than **Rs 54.78 Lakhs.**

OR

(ii) Two orders of value not less than **Rs 34.24 Lakhs each.**

OR

(iii) Three orders of value not less than **Rs 27.39 Lakhs each.**

Note: All Values are exclusive of GST/other Taxes.

Notes for Clause 1.0 above:

The word “executed” means the Bidder should have achieved the criteria specified in the qualifying requirements at Clause 1.0, even if the contract has been started earlier and/or is not completed/ closed and shall be considered as below.

Case-I: The work is started earlier prior to the period stipulated in Clause-1.0, but completed within the stipulated period as mentioned in clause 1.0. In such cases, entire executed value of the relevant work vide that work order shall be considered for evaluation.

Case-II: The work is started and completed within the stipulated period as mentioned in clause 1.0

Case-III: The work is started within the stipulated period as mentioned in clause 1.0 but not completed as on the last date of stipulated period. In such cases, "In Progress" executed value of the relevant work vide that work order as on the last date of stipulated period, shall be considered for evaluation.

Remarks: Any of the above cases shall be supported by documentary evidence issued by the "Owner". "Owner" means the entity which has the original requirement of the subject work and has initiated and awarded the work to the contractor (bidder) for executing the reference work against which the credentials have been submitted. And the "Owner" defined as above is not a contractor to any other entity for the reference work. In case, the bidder has worked as approved sub-Contractor/sub-vendor, he has to provide documentary evidence issued by the "Owner".

2.0 Financial Criteria

The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, should not be less than **Rs 68.48 Lakhs (Rupees Sixty Eight Lakh and Forty Eight Thousand only)**

Notes for Clause 2.0 above:

- (i) In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that financial results of the company are under audit as on the date of techno-commercial bid opening and the certificate from a practicing chartered accountant certifying the financial parameters is not available.
 - (ii) Other income shall not be considered for arriving at annual turnover.
6. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder /his collaborators/associates/subsidiaries/group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
 7. Employer reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
 8. Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening. Bidder shall furnish all the relevant documents online as detailed in Bidding Documents by the stipulated bid submission closing date and time at the address given below.
