TERMS AND CONDITIONS OF THE EXPRESSION OF INTEREST (EOI)

1. The interested Purchasers/ Agencies shall make their own arrangement for transportation of fly ash/conditioned fly ash/pond ash from NTPC Lara site.
2. NTPC-Lara reserves the right to assess the capacity/ capability of the applicant and viability of proposal, based on verification of documents and if required, cross verification for establishment of the capable applicant(s).
3. NTPC-Lara reserves the right to accept or reject any or all applications, cancel/withdraw the EOI process without assigning any reason whatsoever in case situation arises, and in such a case no applicant shall have any claim arising out of such action.
4. Interested Purchasers/ Agencies shall ensure proper care and constant vigil of transportation activities for any damages to any existing properties, which may result in Environmental hazards in any way, in case of award.
5. Interested Purchasers/ Agencies shall have to abide by the guidelines of the Central Government/ State Government and ensure compliance, in case of award.
6. All applicable safety norms to be followed by the interested Purchasers/ Agencies while loading, handling and transportation of fly ash/ pond ash, in case of award.
7. All possible measures will have to be taken by the interested Purchasers/ Agencies, to avoid pollution while transporting, in case of award. No spillage of fly ash will be permitted. If spillage of fly ash takes place, it shall be removed by the agency on urgent basis. If attract any penalty, it shall be in the scope of agency. All necessary liaisoning with the regulatory bodies shall be done by the agency.
8. Transportation of fly ash/ pond ash from production area will be the responsibility of respondent and preferred mode of transportation will be by road.
9. If in case agency is interested in transportation of ash through railway BOX-N racks, Coordination with railways for timely placement of wagons will be the responsibility of the agency.
10. From Kotarlia siding to NTPC-Lara (NLSK) siding, single rail track exists and preference will be given to movement of wagons carrying coal.
11. Interested Purchasers/ Agencies shall be responsible for loading of ash from HCSD Silo to railway rake (space identified by the NTPC-Lara representative). Demurrage charges due to delay in loading onto wagons shall be in the scope of the agency,
12. The agency shall be responsible for proper leveling of fly ash loaded onto wagons & covering of wagons by tarpaulin and shall ensure no overloading so as to attract any charges/levy from railways. If this happen charges shall be in the scope of the agency
13. The agency has to make his own arrangement for sprinkling of water over fly ash at unloading point to avoid fugitive emission of ash in the atmosphere. Also sprinkling of water to be done on the transportation route which will be used by agency. The agency has to arrange water from their own resources for sprinkling.
