5.1.1	a. Bidder should have designed, supplied on hiring basis/ permanent supply basis, erected/
	supervised erection and commissioned/ supervised commissioning of at least one (1) number of
	Chlorine Di-Oxide System/ Plant having at least one (1) number of automated PLC based Chlorine Di-
	Oxide (ClO2) generator of capacity not less than 40 Kg/hr in any industrial application. The above
	system/plant should have been in successful operation for at least one (1) year prior to the date of
	Techno-commercial Bid-opening.
	b1. Bidder who do not fulfill the requirement in clause 5.1.1 (a) above, can also participate provided the Bidder has designed, supplied, erected/supervised erection and commissioned/supervised commissioning of at least one (1) number Gas chlorination plant/system of capacity not less than 120 Kg/hr and should have designed, supplied on hiring basis/ permanent supply basis, erected/supervised erection and commissioned/ supervised commissioning of at least one (1) number of Chlorine Di-Oxide System/Plant having at least one (1) number of automated PLC based Chlorine Di-Oxide (ClO2) generator of capacity not less than 20 Kg/hr. In case of award, the Collaborator(s)/Associate(s) shall be required to furnish an on-demand bank guarantee as per the format enclosed with the bidding documents for a value equal to 2% (two percent) of the contract price in addition to the Contract Performance Security to be furnished by the Bidder.
5.2	Financial Criteria of Bidder
5.2.1	The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, shall not be less than Rs. 1167 Lakhs (Rupees Eleven Hundred and sixty-seven Lakhs only).
5.2.2	Net worth of bidder shall not be less than 100% of the bidder's paid up share capital as on the last day
	of the preceding financial year. In case the Bidder meets the requirement of Net worth based on the
	strength of its Subsidiary(ies) and/or Holding company and/or Subsidiaries of its Holding Companies
	wherever applicable, the Net worth of the Bidder and its Subsidiary(ies) and/or Holding company
	and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of
	their total paid up share capital. However individually, their Net worth should not be less than 75% of

	their respective paid up share capitals.
	Net worth in combined manner shall be calculated as follows:

5.2.3	In case the bidder is not able to furnish its audited financial statements on standalone entity basis,
	the unaudited unconsolidated financial statements of the bidder can be considered acceptable
	provided the bidder furnishes the following further documents on substantiation of its qualification:
	· Copies of the unaudited unconsolidated financial statements of the bidder along with copies
	of the audited consolidated financial statements of the Holding Company.
	A certificate from the CEO/CFO of the Holding Company as per the format enclosed in the bid
	documents stating that the unaudited unconsolidated financial statements form part of the
	consolidated annual report of the company
5.2.4	In case where audited results for the last financial year as on the date of Techno Commercial Bid Opening are not
	available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In
	case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial
	parameters, the audited results of three consecutive financial years preceding the last financial year shall be
	considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as
	per the format enclosed in the bidding documents stating that the financial results of the Company are under
	audit as on the date of Techno-Commercial Bid Opening and the Certificate from the practicing Chartered
	Accountant certifying the financial parameters is not available.
5.2.5	In case a bidder does not satisfy the financial criteria, stipulated at Cl. 5.2.1 and/ or Cl.5.2.2 above on its own, the
	holding company would be required to meet the stipulated turnover requirements at Cl.5.2.1 above, provided
	that the net worth of such holding company as on the last day of the preceding financial year is at least equal to
	or more than the paid-up share capital of the holding company. In such an event, the bidder would be required to
	furnish along with its bid, a Letter of Undertaking from the holding company, supported by Board Resolution, as
	per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award

NOCES	(i) Net worth means the sum total of the paid up share capital and free reserves. Free reserve means
	all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance
	of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be
	reduced from reserves and surplus.
	(ii) Other income shall not be considered for arriving at annual turnover. "Holding Company" and
	"Subsidiary" shall have the meaning ascribed to them as per Companies Act of India.

- 6.0 Bidder has to ensure the following documents to be submitted offline/ online and/or the same should reach in sealed Envelopes before the bid submission deadline prescribed by the Employer, pursuant to ITB Clause 16, failing which bid is liable for rejection
 - a) Tender Fee: as applicable to be paid online or off line. Tender Fee Exemption to MSE Vendors is not applicable for the subject work
 - b) Bid Security Declaration: EMD is nor applicable. However, In lieu of EMD, bid security declaration as applicable shall be submitted by the bidder or Bidders shall accept GTE for Bid Security Declaration on the tendering Portal.
 - c) Integrity Pact: Applicable as per enclosed format.

Any bid not accompanied by an acceptable bid security declaration format, Tender fees and Integrity pact shall be rejected by the Employer as being non-responsive and shall be rejected without being opened.

- 7.0 Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators / associates/ subsidiaries/ group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
- 8.0 Employer reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 9.0 A complete set of Bidding Documents may be downloaded by any interested Bidder from our NIC Portal (https://eprocurentpc.nic.in/nicgep/app).

Note: No hard copy of Bidding Documents shall be issued.

10.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening. Bidder shall furnish Bid Security, Integrity Pact, Deed of Joint Undertaking (if applicable) and Power of Attorney separately offline as detailed in Bidding Documents by the stipulated bid submission closing date and time at the address given below.

11.0 Clarification on bidding documents:

A prospective Bidder requiring any clarification of the Bidding Document shall put the query under Clarification tab of the on-line bid at least three days prior to the clarification end date. EMPLOYER will respond to any request for clarification or modification of the bidding documents that it receives within the time line specified.

No Queries from Bidders, whatsoever, shall be entertained by the Employer beyond the last date of receipt of Queries/ Pre-Bid Conference (if applicable) as specified above.

EMPLOYER will post the Clarifications under Clarification/Corrigendum tab at e-tender website. Bidders can view these clarifications.

- 12.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- 13.0 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
