- **5.0** Qualifying Requirements for Bidders:

The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfill the following Qualifying Requirements.

- 5.1 TECHNICAL CRITERIA
- 5.1.1 The bidder should have executed contract which includes Construction/ Repairing/ Carpeting of Bituminous Road, as per the following within the preceding seven (7) years reckoned as on the date of Techno-commercial l bid opening:
  - a) Executed value not less than Rs. 57 Lakhs in a Single Contract.

OR

b) Executed value not less than Rs. 36 Lakhs in Two Contracts each.

OR

c) Executed value not less than Rs. 29 Lakhs in Three Contracts each.

Notes:

#### Note for clause 5.1.1.:

The word "executed" means the bidder should have achieved the criterion specified in the Qualifying Requirements, even if the total contract is not completed/ closed. In case contract(s) is under execution as on the date of techno-commercial bid opening, the value of work executed till such date will be considered provided the same is certified by the employer.

# Financial Criteria:

- 5.2.1 The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, shall not be less than Rs. 71 Lakhs (Rupees Seventy-One Lakhs only).
- 5.2.2 In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following further documents on substantiation of its qualification:
- Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.

- A certificate from the CEO/CFO of the Holding Company as per the fo1111at enclosed in the bid documents stating that the unaudited unconsolidated financial statements form part of the consolidated annual rep01i of the company.
- 5.2.3 In case where audited results for the last financial year as on the date of Techno Commercial Bid Opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case Bidder is not able to submit the Ce1iificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last f111ai1cial year shall be considered for evaluating the financial perimeters. FU1ther, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial Bid Opening and the Certificate from the practicing Chartered Accountant certifying the financials parameters is not available.

#### Notes

Other income shall not be considered for arriving at annual turnover.

- 6.0 Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators / associates/ subsidiaries/ group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
- **7.0** Employer reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
