**ANY BID NOT ACCOMPANIED BY ACCEPTANCE OF GEPNIC ATTRIBUTE OF “BID SECURITY DECLARATION” SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.**

ii) *“Class-I local suppliers’ only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.”*

**Bidders are requested to give acceptance of meeting the MLC (Minimum Local Content) requirement by accepting the GTE & declaration as per Attachment-23 to Section-VIII of Forms & Procedures (Book 1 of 2).**

By accepting the MLC provision of GTE it will be considered that:-

**“Bidder is ‘Class-I local supplier’ and is meeting the MLC requirement stipulated in Annexure-I to BDS.**

**Also supplier has not been debarred / banned by any other procuring entity for violation of ‘Public Procurement (Preference to Make In India), Order 2017’ (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)”.**

No further claim in this regard shall be entertained by the Employer.

In case false declaration in respect of Local content, same shall be treated as false declaration and will be dealt in line with the Fraud Prevention Policy of NTPC.

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

5. Bidder has to ensure the following documents to be submitted offline (in case paid in modes other than on-line payment) and the same should reach in sealed envelopes before the bid

submission deadline prescribed by the Employer, pursuant to ITB Clause 18, failing which bid is liable for rejection

- a) Tender Fee: Applicable
- b) Integrity Pact: Not Applicable

**Any bid not accompanied by Bid Security Declaration, Tender fees (If applicable) and/or Integrity pact (If applicable) shall be rejected by the Employer as being non-responsive and shall be rejected without being opened.**

### 6. Qualifying Requirements for Bidders:

The Bidder should meet the minimum Qualifying Requirements as stipulated here under:

#### **1.0 Technical Criteria**

1.1 The bidder should have executed at least one work of 'Construction/Repair' of Cement Concrete Road, in the preceding seven (7) years prior to the date of techno-commercial bid opening.

1.2 The bidder should have executed 'Civil Construction / Civil Maintenance' work(s), in the preceding seven (7) years prior to the date of techno commercial bid opening, meeting the following criteria:

(i) Single order of value not less than **Rs 99.22** Lakhs.

OR

(ii) Two orders of value not less than **Rs 62.01** Lakhs each.

OR

(iii) Three orders of value not less than **Rs 49.61** Lakhs each.

#### **Note:**

1. All values are exclusive of GST/other Taxes.
2. For purpose of evaluation, executed value of overall Purchase Order/ Award letter shall be considered.
3. Civil Construction / Civil Maintenance work does not include 'Sanitation/Water Supply' related jobs.

#### **Notes for Clause 1.0 above:**

The word "executed" means the Bidder should have achieved the criteria specified in the qualifying requirements at Clause 1.0, even if the contract has been started earlier and/or is not completed/ closed and shall be considered as below.

**Case-I:** The work is started earlier prior to the period stipulated in Clause-1.0, but completed within the stipulated period as mentioned in clause 1.0. In such cases, entire executed value of the relevant work vide that work order shall be considered for evaluation.

**Case-II:** The work is started and completed within the stipulated period as mentioned in clause 1.0

**Case-III:** The work is started within the stipulated period as mentioned in clause 1.0 but not completed as on the last date of stipulated period. In such cases, "In Progress" executed value of the relevant work vide that work order as on the last date of stipulated period, shall be considered for evaluation.

Remarks: Any of the above cases shall be supported by documentary evidence issued by the "Owner". "Owner" means the entity which has the original requirement of the subject work and has initiated and awarded the work to the contractor (bidder) for executing the reference work against which the credentials have been submitted. And the "Owner" defined as above is not a contractor to any other entity for the reference work. In case, the bidder has worked as approved sub-Contractor/sub-vendor, he has to provide documentary evidence issued by the "Owner".

### **2.0 Financial Criteria**

The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, should not be less than **Rs 124.03 Lakhs** (Rupees One Crore Twenty Four Lakhs and Three Thousand only).

#### **Notes for Clause 2.0 above:**

(i) In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that financial results of the company are under audit as on the date of techno-commercial bid opening and the certificate from a practicing chartered accountant certifying the financial parameters is not available.

(ii) Other income shall not be considered for arriving at annual turnover.

7. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators / associates/ subsidiaries/ group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
8. Employer reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
9. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

10. A complete set of Bidding Documents may be downloaded by any interested Bidder from our NIC Portal (<https://eprocurmentpc.nic.in/nicgep/app>).

11. Clarification on bidding documents:

A prospective Bidder requiring any clarification of the Bidding Document shall put the query under Clarification tab of the on-line bid at least three days prior to the clarification end date. EMPLOYER will respond to any request for clarification or modification of the bidding documents that it receives within the time line specified.

EMPLOYER will post the Clarifications under Clarification/Corrigendum tab at e-tender website. Bidders can view these clarifications.

# No Queries from Bidders, whatsoever, shall be entertained by the Employer beyond the last date of receipt of Queries/ Pre-Bid Conference (if applicable) as specified above.

12. Issuance of Bidding Documents to any Bidder shall not construe that such Bidder is considered qualified.

13. Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
