3.0 Qualifying Requirements:

In addition to the requirements stipulated in Section ITB (Instructions to Bidders), the Bidder shall also meet the Qualifying Requirements stipulated hereunder:

1.1TECHNICAL CRITERIA:

bidder should have The "designed, supplied, erected/ supervised erection commissioned/supervised commissioning, of at least one (01) no. of Sewage Treatment plant (STP) with min. capacity of 150 KLD based on "Moving Bed Bio-Reactor" film (MBBR) "Membrane Bio Reactor" (MBR) process for waste water (effluent), including

associated civil works, during last seven (07) years, which should be in successful operation for at least one(01) year as on the date of Techno- commercial bid opening.

AND

1.2 Prospective bidder should have executed similar works, during last seven (07) years, reckoned from the date of Techno-commercial bid opening, as per any of the following criteria:

One executed Work-order valuing not less than Rs. 104.76 Lakhs (INR One Hundred-four Lakhs and Seventy-six Thousands only).

OR

Two executed Work-orders, each valuing not less than Rs. 65.48 Lakhs (INR Sixty-five Lakhs and Forty-eight Thousands only).

OR

Three executed Works-orders, each valuing not less than Rs. 52.38 Lakhs (INR Fifty-two Lakhs and Thirty- eight Thousands only).

NOTE: Bidder have the option of submitting same/ different work-orders for meeting criteria 1.1 & 1.2.

- 2.0 **FINANCIAL CRITERIA:**
 - Average annual financial turnover (AATO) of the Bidder during preceding three (03) consecutive financial years prior to the date of techno-commercial bid opening should not be less than Rs. 131.00 Lakhs (INROne Hundred Thirtyone Lakhs only).
- 3.1 In case a bidder does not satisfy the financial criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements as above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the Bidder would be requested to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the Bid Documents, pledging unconditional & irrevocable financial support for the execution of the Contract by the Bidder in case of award.
- 3.2 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided bidder the further furnishes the following documents substantiation of its qualification:

Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.

A certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated financial statements of the Holding Company..

3.3 In cases where audited results for the last financial year as on the date of Techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for three the (03)consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.

Further, a certificate would be required from CEO/CFO as per the format enclosed in the bidding document stating that the financial results of the company are under audit as on the date of Technocommercial bid opening and the certificate from the practicing Chartered Accountant certifying financial parameters is not available.

3.4 Clarificatory Notes for the Clauses above:

- I. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above within the preceding seven (07) years period, even if the total contract is started earlier and/or is not completed/closed.
- II. Bidder must submit documentary evidence issued by the owner, in support of having met the Qualifying

requirements, along-with their Technical offer. These documentary evidence may include:

- IV. Reference work executed by bidder as a subcontractor may also be considered provided the certificate issued by the main contractor is duly certified by the Project Authority specifying the work executed by the sub-contractor in support of the qualifying requirements.
- V "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.
- **VI. Other income** shall not be considered for arriving at annual turnoverfigures.
- VII. For Annual Turnover indicated in foreign currency, the exchange rate as on seven (07) days prior to the date of techno-commercial bid opening shall be used.

VII All Financial **figures** mentioned above are **exclusive of GST**.

4.0 SUBMISSION OF BIDS:

a.
