NTPC invites on-line (e-tender) bids from eligible bidders for "Procurement of 990AH Ni-cd Batteries for 220V and 24V Battery Bank".

Micro and Small Enterprises (MSEs) registered with District Industries Centers (DICs) or NSIC or Khadi & Village Industries Commission (KVIC) or Khadi & Village Industries Board (KVIB) or Coir Board or Directorate of Handicrafts and Handloom or Any other body specified by Ministry of Micro, Small & Medium Enterprises (M/o MSME) having Udyam Registration, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit.

Detailed specification of material and other terms & conditions are mentioned in the tender documents.

(I) Qualifying Requirements (QR)

1.0 Technical Criteria:

Clause 1.1: The bidder should have "Manufactured, Supplied and Commissioned Ni-Cd 1.2 Volts cells of capacity not less than 990 AH each in a Battery bank of 220V DC or more" at least in any one installation and should have been in successful operation for a period of at least one (01) year.

AND

Clause 1.2: The bidder should have executed order(s) for "Manufacture, Supply and Commissioning of Ni-Cd 1.2 Volts cells of capacity not less than 990 AH each in a Battery bank of 220V DC or more" during the preceding seven (07) years, reckoned as on date of techno-commercial bid opening with order values meeting any of the following:

(i) Single order with executed value not less than Rs.58.88 Lakhs.

OR

(ii) Two orders with executed value not less than Rs. 36.80 Lakhs each.

OR

(iii) Three orders with executed value not less than Rs. 29.44 Lakhs each.

2.0 Financial Criteria of Bidder

1. The average annual turnover of the bidder, in the preceding three (03) financial years, reckoned as on the date of Techno-commercial bid opening shall not be less than Rs 73.60 Lakhs (Rupees Seventy-three lakhs and sixty thousand only).

Notes:

- a) In case where audited results for the last financial year as on the date of techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
- b) For the purpose of arriving at the executed value of work/supply specified at 1.2 above, basic amount only shall be considered. In case of a contract inclusive of Taxes, agency has to provide the break-up of basic value and tax.
- c) Other income shall not be considered for arriving at annual turnover.
- d) The value of the work/supply completed in the preceding seven (07) years reckoned as on date of techno-commercial bid opening, even if it has been started earlier, will only be considered for establishing the qualifying requirements.
- e) The word "executed" mentioned at clause 1.2 above means; bidder should have achieved the criteria specified in above QR even if the total contract is not completed / closed.
- f) The bidder should submit the documentary proof for establishing the QR requirements at 1.0 and 2.0 above.

(II) GENERAL TERMS AND CONDITIONS

1. A complete set of bid documents may be downloaded by any interested bidder by logging at our site <https://eprocurmentpc.nic.in/>. For logging on to our site, the bidder would require user id and password which can be created by themselves at our site from Online Bidder Enrollment tab. First time users, who do not have vendor code in NTPC database are required to approach NTPC at least 05 (Five) working days prior to Bid Submission End Date along with duly filled EFT Forms, Cancelled Cheque, Copy of PAN, Copy of TIN, Copy GST Registration, other documents related to credentials etc.
2. Payment of Tender Fee by any bidder shall not construe that such bidder is considered to be qualified.
3. Notwithstanding anything stated above, NTPC reserve the right to assess bidder's capability and capacity of the bidder for carrying out the supplies and the decision of NTPC in this regard shall be final.
4. NTPC reserves the right to accept or reject any or all the tenders in part or full including rejection of any request for issue of tender documents, alter the quantities or split the order without assigning any reason thereof.
5. Bidders have to submit bids on line on the NTPC e- tender Portal (<https://eprocurmentpc.nic.in/>). Single Stage two envelope bidding system will be



followed for the subject package. Technical & Price Bids shall be submitted online before expiry of Bid Submission End Date. Offline documents (Like Tender Fee, Bid Security exemption & any other document, if specified in SPC) should be submitted/ received at NTPC Faridabad before expiry of Bid Submission Date, as detailed here under:

- (i) Envelope-1 (Marked as Tender Fee/ Bid Security Exemption) must contain Tender Fee, BID Security exemption & any other document specified in SPC (Special Purchase Conditions).
6. Envelope-1 (Marked as Tender Fee/Bid Security exemption) shall be opened first and contents of this envelope shall be checked before opening of the Technical Bid/Envelope- 2 (Marked as QR). Technical Bid/Envelope-2 (Marked as QR) of only those bidders whose Tender Fee/ Bid Security Declaration are found valid & acceptable, will be opened. If the bidder qualifies as per the QR and terms & conditions of NIT, their price bid shall be opened on the scheduled date as notified in NIT or on the date to be intimated after evaluation of technical bids.
7. Above details are only indicative. Other detailed terms and conditions shall be as per tender documents.
