- **5.0** The date of opening of Price Proposal shall be intimated separately by NTPC after completion of evaluation of Techno-Commercial Proposal.
- 6.0 Tender Fee shall be paid separately online (by NEFT/RTGS) through GePNIC Portal.

 Micro and Small Enterprises (MSEs) registered with District Industries Centres having EM Part-II, Udyog Aadhaar Memorandum (UAM), Udyam Registration or any other body specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006 and any further notifications issued by MSME Ministry, for goods produced and services rendered, shall be issued the bid documents free of cost. Exemption Certificate towards Tender Fee and purchase preference for MSE's in line with Clause 4.0 of ITB along with the MSE Undertaking as per the format is to be uploaded in Fee Cover of OnlineBid
- **7.0** Earnest Money Deposit: Bidders shall necessarily accept the following General Technical Evaluation (GTE) of the Tender without which Bidder cannot submit their Bid "Do You Accept Bid Security Declaration"
- **8.0** All credential filled up formats & supporting documents as asked by NTPC are to be given online as attachments with the bid.
- 9.0 The above benefits to MSEs are meant for procurement of only goods produced and services rendered by MSEs. However, traders are excluded from the purview of Public Procurement Policy and not eligible for Benefits to MSEs. Also, benefits under Public Procurement Policy for MSEs shall not be extended in Works Contract.
- 10.0 A complete set of Bidding Documents may be downloaded by any interested Bidder at our E Tender Site (https://eprocurentpc.nic.in/nicgep/app). For logging on to the E Tender Site, the bidder would require to create user ID and Password as per the Bidder's Manual Kit provided in the aforementioned web site. The payment (non-refundable) of the cost of the documents as mentioned above in the form of a crossed account payee demand draft in favour of NTPC Ltd., Payable at Visakhapatnam shall be submitted in a sealed envelope separately offline by the stipulated bid submission closing date and time at the address given below.

11.0 Qualifying Requirements:

1.0 Technical Criteria:

- 1.1) The bidder should be a manufacturer/ authorized dealer of manufacturer of Butterfly Valves and should have supplied to any industry.
- 1.2) The bidder should have executed order(s) for "Supply of Valves" during the preceding seven (07) years, reckoned as on date of techno-commercial bid opening with order values meeting any of the following:

i) Single order with executed value not less than Rs. 86.54 Lakhs.

ii) Two orders with executed value not less than Rs. 54.09 Lakhs each.

OR

iii) Three orders with executed value not less than Rs. 43.27 Lakhs each

2.0 Financial Criteria:

2.1 The average annual turnover of the bidder, in the preceding three (03) financial years, reckoned as on the date of Techno-commercial bid opening shall not be less than Rs 108.18 Lakhs (Rupees One hundred Eight lakhs and Eighteen thousand only).

3.0 Notes:

- a) In case where audited results for the last financial year as on the date of technocommercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
- b) For the purpose of arriving at the executed value of work/supply specified at **1.2** above, basic amount only shall be considered. In case of a contract inclusive of Taxes, agency has to provide the break-up of basic value and tax.
- c) Other income shall not be considered for arriving at annual turnover.
- d) The value of the work/Supply completed in the preceding seven (07) years reckoned as on date of techno-commercial bid opening, even if it has been started earlier, will only be considered for establishing the qualifying requirements.
- e) The word "executed" mentioned at clause 1.2 above means; bidder should have achieved the criteria specified in above QR even if the total contract is not completed / closed.
- f) In case the bidder is "authorized dealer of a manufacturer", then they should submit tender specific valid authorization from their manufacturer and in such case the bidder can furnish their own document or document of manufacturer as documentary proof for qualifying requirement.
- g) The bidder should submit the documentary proof for establishing the QR requirements at 1.0 and 2.0 above.
- **12.0** Notwithstanding anything stated above, the Employer reserves the right to undertake a physical assessment of the capacity and capabilities including financial capacity and capability of the Bidder / his Collaborator(s) / Associate(s) / Subsidiary(ies) / Group Company(ies) to perform the Contract, should the circumstances warrant such assessment in the overall interest of the Employer.

The physical assessment shall include but not be limited to the assessment of the office/facilities/banker's/reference works by the Employer. A negative determination of such assessment of capacity and capabilities may result in the rejection of the Bid.

The above right to undertake the physical assessment shall be applicable for the qualifying requirements stipulated above.

- 13.0 NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subjectpackage without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
- 14.0 Issuance of Bidding Documents to any bidder shall not construe that bidder is considered qualified.
- **15.0** Participation in the tender does not automatically mean that the bidders are considered qualified. NTPC shall evaluate the qualifying requirements of each bidder as per NIT after opening of Technical Commercial bids and the bids of the bidder who is not meeting the qualifying requirement shall be treated as non-responsive.
