2.0 **BRIEF SCOPE OF WORK**

The scope of the proposed set up of Electro coagulation system shall include Design, Engineering, Fabrication, Packing, Forwarding, Supply, Transportation and handling, Custom duty (and any other duties), Freight, Insurance Unloading, Storage, Construction, Erection, Testing, Commissioning, PG Test Electrocoagulation system at NTPC Solapur in line with the specifications provided in this document.

3.0 NTPC intends to finance subject Package through Domestic Commercial Borrowings / Own sources.

6.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.

7.0 Interested Vendors may download the tender documents from website "https://eprocurmentpc.nic.in". The website works best on Internet explorer 10 and above. Tender Fee may be deposited along with Bid Security.

Note: No hard copy of Bidding Documents shall be issued.

8.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening. Bidder shall furnish Bid Security Declaration Form, Deed of Joint Undertaking / Joint Venture / Consortium Agreement / Integrity Pact (if applicable), and Power of Attorney separately offline as detailed in Bidding Documents by the stipulated bid submission closing date and time at the address given below.

9.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.

10.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents. However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

11. **Class-I local suppliers only** are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."
