1.0 NTPC Limited (NTPC) invites online bids on "Single Stage Two Envelope Bidding basis" from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

2.0 BRIEF SCOPE OF WORK

The Scope of work includes R&M OF OVERHEAD HT LINES IN NTPC KORBA TOWNSHIP for Korba SUPER THERMAL POWER PROJECT as per technical specifications Section-VI of bidding documents and all the application General Conditions of Contract of NTPC.NTPC intends to finance subject Package through Internal Resources.

4.0 All bids must be accompanied by **Bid Security Declaration** in the form as stipulated in the Bidding documents. Bid Security Declaration shall be submitted by acceptance of General Technical Evaluation (GTE) Attribute "**Do you accept Bid Security Declaration**" in Gepnic portal.

In case a bidder does not submit the aforesaid declaration, then the bid shall be rejected by employer as being non-responsive and shall not be opened.

Option for Online payment of tender fee is also made available at GepNIC/e tender portal. Bidders are requested to please avail the facility.

- 5.0 Bidder has to ensure the following documents to be submitted online, pursuant to ITB Clause 15, failing which bid is liable for rejection
 - a) Tender Fee: As applicable
 - b) Earnest Money Deposit/Bid Security:

All bids must be accompanied by "Bid Security Declaration" in lieu of Bid Security in the GePNIC attribute.

Any bid not accompanied by acceptance of GePNIC attribute of "Bid Security Declaration" shall be rejected by the employer as being non-responsive and shall not be opened.

6.0 A complete set of Bidding Document may be downloaded by any interested Bidder from https://eprocurentpc.nic.in/nicgep/app. Tender fee (in case of offline payment) as mentioned above is required to be submitted in separately sealed envelope at the address mentioned in the bidding document before stipulated date & time of submission of bid.

Prospective bidders are compulsorily required to provide GSTIN number with Tender Fee.

7.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfil the following Qualifying Requirements

7.1 TECHNICAL Criteria

Route 1:

7.1.1 The bidder should be an A Class Electrical Contractor and should have executed supply, installation, testing & commissioning of TRIPLE EXTRUDED Covered Conductors with water blocking capability along with all its accessories of 11 kV or higher voltage as per EN 50397-1

Sub QR applicable in case the bidder himself is not an A-Class Electrical Contractor.

Route-2:

Bidder who do not fulfill the requirement in Route-1 above, can also participate provided Bidder is an A-Class Electrical Contractor who has carried out installation, testing and commissioning of overhead lines of 11 kV or higher voltage.

AND

Bidder shall associate/collaborate with a party who has executed supply, installation, testing & commissioning of TRIPLE EXTRUDED Covered Conductors with water blocking capability along with all its accessories of 11 kV or higher voltage as per EN 50397-1 in India or abroad.

In such a case, the Bidder shall be required to furnish a Deed of Joint Undertaking(s) (DJU)* jointly executed by the Bidder and the Collaborator(s)/ Associate(s) and each executants of DJU shall be jointly and severally liable to the Employer for successful performance of system executed as per the format enclosed with the bidding documents.

In such a case the "Undertaking to be jointly executed by the Bidder and the collaborator/associate for complying the provisions of Deed of Joint Undertaking" should be submitted along with the bid failing which Bidder shall be disqualified and its bid shall be rejected.

*Further, the bidder emerging as the successful Bidder shall be required to submit the applicable DJU(s) jointly executed by the Bidder and the Collaborator(s)/ Associate(s) and each executants of DJU shall be jointly and severally liable to the Employer for successful performance of system executed as per the format enclosed with the Bidding documents, at the earliest but not later than fifteen (15) days from the date of opening of the price bid / completion of Reverse Auction process (if applicable), failing which the Bid may be liable for rejection and Bid Security may be forfeited by the Employer.

In case of award, the Collaborator(s)/Associates shall be required to furnish an on demand bank guarantee as per the format enclosed with the bidding documents for a value equal to 1% (one percent) of the contract price in addition to the Contract Performance Security to be furnished by the Bidder.

7.1.2 The bidder should have successfully executed the works of Supply, Erection, Testing and Commissioning of Overhead Covered Conductors and its Accessories for 11KV or higher voltages during the last seven (07) years prior to the date of Techno- commercial bid opening as per the following criteria:

Executed value not less than ₹ 538 Lakh in a single contract

OR

Executed value not less than ₹ 336 Lakh in two contracts each

OR

Executed value not less than ₹ 269 Lakh in three contracts each

7.1.3 At least one system cited in credentials for 7.1.2 above should be in successful operation for at least one year as on the date of techno commercial bid opening.

Note: The word executed means the bidder should have achieved the criterion specified in the QR, even if the total contract is not completed / closed. In case of contracts under execution as on date of techno commercial bid opening, the value of the work executed till such date will be considered provided the same is certified by the employer.

7.2 Financial Criteria:

- 7.2.1 The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, shall not be less than **Rs. 336 Lakhs** (Rupees Three Hundred and Thirty Six Lakhs only).
- 7.2.2 Net worth of bidder shall not be less than 100% of the bidder's paid up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net worth based on the strength of its Subsidiary(ies) and/or Holding company and/or Subsidiaries of its Holding Companies wherever applicable, the Net worth of the Bidder and its Subsidiary(ies) and/or Holding company and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of their total paid up share capital. However individually, their Net worth should not be less than 75% of their respective paid up share capitals.

Net worth in combined manner shall be calculated as follows:

Net worth (combined)=(x1+x2+x3)/(y1+y2+y3)x100 where x1, x2, x3 are individual net worth which shall not be less than 75% of the respective paid up share capitals and y1, y2, y3 are individual paid up share capitals.

- 7.2.3 In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following further documents on substantiation of its qualification.
 - Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.
 - A certificate from the CEO/CFO of the Holding Company as per the format enclosed in the bid documents stating that the unaudited unconsolidated financial statements form part of the consolidated annual report of the company.
- 7.2.4 In case where audited results for the last financial year as on the date of Techno Commercial Bid Opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial Bid Opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
- 7.2.5 In case a bidder does not satisfy the financial criteria, stipulated at Cl. 7.2.1 and/ or Cl.7.2.2 above on its own, the holding company would be required to meet the stipulated turnover requirements at Cl.7.2.1 above, provided that the net worth of such holding company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the holding company. In such an event, the bidder would be required to furnish

along with its bid, a Letter of Undertaking from the holding company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award...

NOTES

- (i) Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- (ii) Other income shall not be considered for arriving at annual turnover.
- (iii) "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.
- 8 Class-I local suppliers'/ 'Class-I local suppliers and Class-II local suppliers'' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

OR

Bids from 'Class-I local suppliers' as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT shall be eligible for purchase preference. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

NOTE:

Bidders are requested to give acceptance of being Class-I Local Supplier (Minimum Local Content equal to or more than 50%) by accepting the GTE & declaration in Bid Form.

By accepting the MLC provision of GTE it will be considered that:-

"Bidder is 'Class-I local supplier' and is meeting the MLC requirement stipulated in Annexure-II to BDS.

Also supplier has not been debarred / banned by any other procuring entity for violation of 'Public Procurement (Preference to Make In India), Order 2017' (PPP-MII Order) dated 15.06.2017 and its subsequent revisions / amendments issued by Department for Promotion of Industry and Internal trade (DPIIT)".

In case false declaration in respect of Local content, same shall be treated as false declaration and will be dealt in line with the Fraud Prevention Policy of NTPC.

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

- 9 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.
 - However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.
- 10 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- 12 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
