2.0 Brief Details :

Sipat Super Thermal Power Station is located at [Sipat](#) in [Bilaspur district](#) in state of [Chhattisgarh](#). The power plant is one of the [coal](#) based power plants of [NTPC](#). The coal for the power plant is sourced from Dipika Mines of [South Eastern Coalfields Limited](#).

The project has an installed capacity of 2980 MW consisting of two stages, stage one which got commissioned late was of 3 units of 660 MW each involving super-critical boilers technology and stage two consisted of 2 units of 500 MW each.

3.1	<u>TECHNICAL CRITERIA :</u>
3.1.1	<p>The bidder should have executed contract for Mechanical Maintenance/ Mechanical Erection of ash disposal pipelines or Ash water recirculation pipelines or Ash Dyke Sprinkling System as per the following during the preceding seven (7) years reckoned as on the date of techno commercial bid opening:</p> <p>a) Executed value not less than Rs. 281 Lakh in a single order</p> <p>OR</p> <p>b) Executed value not less than Rs. 175 Lakh each in two orders.</p> <p>OR</p> <p>c) Executed value not less than Rs. 140 Lakh each in three orders.</p>
Notes	<p>Notes for clause 3.1.1 above:</p> <p>1. The word “executed” means the bidder should have achieved the criterion specified in the Qualifying Requirements, even if the total contract is not completed/ closed. In case contract(s) is under execution as on the date of techno-commercial bid opening, the value of work executed till such date will be considered provided the same is certified by the employer.</p> <p>2. For the purpose of arriving at the executed value of work specified at 3.1.1 above, Basic amount only shall be considered. In case of contract inclusive of taxes, agency has to provide the break –up of basic value and taxes.</p>
3.2	<u>FINANCIAL CRITERIA :</u>
3.2.1	The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, shall not be less than Rs. 351 Lakh (Rupees Three Crore Fifty One Lakh Only).
3.2.2	Net worth of bidder shall not be less than 100% of the bidder’s paid up share capital as on the last day of the preceding financial year. In case the Bidder meets the requirement of Net worth based on the strength of its Subsidiary(ies) and/or Holding company and/or Subsidiaries of its Holding Companies wherever applicable, the Net worth of the Bidder and its Subsidiary(ies) and/or Holding company and/or Subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of their total paid up share capital. However individually, their Net worth should
