Detailed specification of material and other terms & conditions are mentioned in the tender documents.

## (I) Qualifying Requirements (QR)

Qualifying Requirements for "Procurement of Grinding Elements for 8.5E10 Mills, Stage-I at NTPC Ramagundam

## 1.0 Technical Criteria-A:

The bidder shall satisfactorily establish that they fulfil any of the following Routes of technical criteria-A under clause-1.0, in addition to other criteria under clause no. 2.0 & 3.0.

## Route-01:

1.1 The bidder should be a manufacturer of Ball & Race type coal pulverizers and should have supplied such coal pulverizers to coal fired Units of 60 MW or higher capacity to thermal power station and which is in successful operation for at least two (02) years prior to the date of techno-commercial bid opening.

OR

## Route-02:

1.2 (a) The bidder should be a manufacturer of Ni hard/ Hi Chrome castings with in-house casting facilities with minimum annual manufacturing capacity of 60 MT and should have supplied at least One set of grinding rings (i.e top and bottom ring) of size 85 inches or above and one set (i.e. 10 nos. of balls) of grinding balls of size 28 inches or above of Ni Hard-IV / Hi chrome used in coal pulverizers during last seven (07) years prior to the date of techno-commercial bid opening.

#### **AND**

b) The bidder should have either himself or through a company / agency in which he has controlling stake, own following manufacturing & testing facilities for use by the bidder for manufacturing of the grinding rings (Bidder to furnish proof of ownership/controlling stake of the facilities along with his bid):

# Manufacturing Facilities:

- a) Induction / Cupola / Induction Arc Furnace (Single/Multiple) for melting iron 8.0 (Eight) Tonnes at a time.
- b) Machining facilities for machining grinding rings.
- c) Heat treatment facility for grinding balls.

## **Testing Facilities:**

- a) Hardness testing
- b) Micro Structure testing
- c) Chemical Composition testing
- d) Ultrasonic testing machine
- e) Spectrometer / spectrogram
- f) Outside Micrometers

## Note for 1.0:

The bidder has to establish the size of the Rings & balls and usage of Rings & balls in Coal Pulverisers by submitting the documentary evidence (if not mentioned in the supporting PO's furnished)

## 2.0 Technical Criteria-B:

2.1 The bidder should have executed orders for "Supply of Ball & Race type Coal pulverizers / Grinding elements for Coal pulverizers" during the preceding seven (07) years, reckoned as on date of techno-commercial bid opening with order values meeting any of the following:

i) Single order with executed value not less than Rs.187.78Lakhs.

OR

ii )Two orders with executed value not less than Rs. 117.36 Lakhs each.

OR

iii) Three orders with executed value not less than Rs. 93.89 Lakhs each.

Note for 2.0: "Grinding element" means rings/balls or rings & balls for Ball & Race type Coal pulverizers.

#### 3.0 Financial Criteria

3.1 The average annual turnover of the bidder, in the preceding three (03) financial years, reckoned as on the date of Techno-commercial bid opening shall not be less than Rs 234.72Lakhs (Rupees Two hundred thirty four lakhs and seventy two thousand only).

## 4.0 Notes:

a)In case where audited results for the last financial year as on the date of techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.

b) For the purpose of arriving at the executed value of work specified at 2.1 above, basic amount only shall be considered. In case of a contract inclusive of Taxes, agency has to provide the break-up of basic value and tax.

- c) Other income shall not be considered for arriving at annual turnover.
- d)The value of the work completed in the preceding seven (07) years reckoned as on date of techno-commercial bid opening, even if it has been started earlier, will only be considered for establishing the qualifying requirements.
- e) The word "executed" mentioned at clause 2.1 above means; bidder should have achieved the criteria specified in above QR even if the total contract is not completed / closed.
- f) The bidder should submit the documentary proof for establishing the QR requirements at 1.0 and 2.0 & 3.0 above.

# (II) <u>DOCUMENTS TO BE SUBMITTED BY THE BIDDER WITH THE</u> TECHNICAL BID:

Legible copies of the following documents duly authenticated by the authorized representative of the bidder shall be submitted in support of the qualifying requirements along with technical bid:

a) Copy of Deed of Joint undertaking, if applicable. Original copy must be sent in

- sealed envelope with offline documents like Tender fee etc.
- b) Relevant Order copies along with Proof of Execution (copy of Invoice, Shipping Documents, Certified copy of Bank Statement of payment etc)
- c) Soft copy of Micro & Small Enterprise (MSE) certificate (Udyam Registration Certificate), as an exemption certificate in lieu of Tender fee/EMD, should also be uploaded in Fee/EMD envelope of online bid.
- d) Copy of Profit & Loss Account & Balance Sheet for the preceding three (3) completed financial years as on date of bid opening
- e) Copy of Power of Attorney of Authorized Signatory.
- f) Other documents in support of QR.

#### NOTE:

- 1. NTPC if so desire may verify the performance of the bidder from their respective clients
- 2. The Bidder's attention is also drawn to ITB Clause 10.1 (II) (f)/ ITB Clause 26, as per which, only the reference Works/ Orders whose details have been declared in relevant Attachment in their Bid, shall be considered to ascertain the bidder's compliance to the specified Qualifying Requirements (QR).

# (III) GENERAL TERMS AND CONDITIONS

- 1. A complete set of bid documents may be downloaded by any interested bidder by logging a tour site <a href="https://eprocurentpc.nic.in/">https://eprocurentpc.nic.in/</a>. For logging on to our site, the bidder would require user id and password which can be created by themselves at our site from Online Bidder Enrollment tab. First time users, who do not have vendor code in NTPC database are required to approach NTPC at least 05 (Five) working days prior to Bid Submission End Date along with duly filled EFT Forms, Cancelled Cheque, Copy of PAN, Copy of TIN, Copy GST Registration, other documents related to credentials etc.
- 2. Payment of Tender Fee by any bidder shall not construe that such bidder is considered to be qualified.
- 3. Notwithstanding anything stated above, NTPC reserve the right to assess bidder's capability and capacity of the bidder for carrying out the supplies and the decision of NTPC in this regard shall be final.
- 4. NTPC reserves the right to accept or reject any or all the tenders in part or full including rejection of any request for issue of tender documents, alter the quantities or split the order without assigning any reason thereof.
- 5. Bidders have to submit bids online on the NTPC e-tender Portal (https://eprocurentpc.nic.in/). Single Stage two envelope bidding system will be followed for the subject package. Technical & Price Bids shall be submitted online before expiry of Bid Submission End Date.
