2.1	<b><u>Technical Criteria</u></b>
2.1.1	<p>The bidder should be a manufacturer or an authorised supplier of any one or more of the following CW (Cooling Water) treatment Chemicals:</p> <p>a) ZINC SULPHATE IS NO. 1880:1977 TECH.(TR)</p> <p>AND/OR</p> <p>b) PHOSPHONO BUTANE TRICARBOXYLIC ACID (PBTC)</p> <p>AND/OR</p> <p>c) CO-POLYMER DISPERSANT: ACTIVE CONTENT-50%</p> <p>AND/OR</p> <p>d) BIO-DISPERANT</p> <p>AND/OR</p> <p>e) TER-POLYMER DISPERSANT-TECHNICAL GRADE</p>
2.1.2	<p>The Bidder should have executed contract for supply of CW (Cooling Water) treatment Chemicals as per following within the preceding seven (7) years reckoned as on date of Techno-commercial bid opening:</p> <p>i) Executed value not less than Rs 108 Lakhs in a Single Contract.</p> <p style="text-align: center;">OR</p> <p>ii) Executed value not less than Rs 68 Lakhs in Two Contracts each.</p> <p style="text-align: center;">OR</p> <p>iii) Executed value not less than Rs 54 Lakhs in Three Contracts each.</p>

2.2.2	<p>In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following further documents on substantiation of its qualification:</p> <ul style="list-style-type: none"> <li>• Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.</li> <li>• A certificate from the CEO/CFO of the Holding Company as per the format enclosed in the bid documents stating that the unaudited unconsolidated financial statements form part of the consolidated annual report of the company.</li> </ul>
2.2.3	<p>In case where audited results for the last financial year as on the date of Techno Commercial Bid Opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial Bid Opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.</p>

1. Techno Commercial Bid Opening date shall be first scheduled Techno Commercial Bid Opening Date.
2. Bidder should have a separate valid GST registration number and PAN Number.

Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators/ associates/ subsidiaries/group companies to perform the contract should the circumstances warrant such assessment in the overall interest of the Employer.
