1.0 Technical Criteria:

- a) The agency should have successfully completed/executed Civil building construction work or Civil Maintenance work in any PSU/NTPC/APCPL/State Electricity Boards/Govt./Pvt. Companies/Institution during last 7 years ending last day of the month previous to date of issue of the NIT, either of the following values:-
- (i) One executed works costing not less than Rs. 66.59 Lakhs.

OR

(ii) Two executed works costing not less than Rs. 41.62 Lakhs each.

OR

(iii) Three executed works costing not less than Rs. 33.29 Lakhs each.

2.0 Financial Criteria:

- 2.1 The average annual turnover of the Bidder in the three preceding financial years, as on the date of technical bid opening shall not be less than Rs. 66.59 Lakh.
- 2.2 In case where audited results for the last preceding financial year as on the date of technocommercial bid opening are not available, the financial result certified by a practicing chartered accountant shall be considered acceptance. In case, bidder is not able to submit the certificate from practicing charted accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial years shall be considered for evaluating the financial parameters.

- a) Word executed means the bidder should have achieved the progress specified in the QR even if the total contract is not completed/ closed and the same shall be supported by the documentary evidence.
- **b)** Other income will not be considered in evaluation of turnover.
- c) In case where audited results for the last preceding financial year, is not available, certificate of financial statement from a practicing chartered Accountant shall also be acceptable.

PART-II: GENERAL REQUIREMENTS:

- 1.0 The bidder should have PAN, GST Registration, PF Code and Valid Electrical License (as applicable) etc. It may be clearly noted that first payment shall be released only after submission of these documents.

- 3.0 The bids shall submitted up to 3:00 P.M. on bid submission closing date and tender shall be opened at 3:15 PM on due date of bid-opening. If the date of opening happens to be a closed holiday, bids shall be received till next working day up to 3.15 PM and opened on the next working day.
- 4.0 The bids submitted without tender cost and bid security declaration shall not be considered for opening.
- 5.0 Detailed specifications of jobs including scope of work and all terms and conditions of NIT are given in tender documents.
- 6.0 For fulfilling the Qualifying Requirements, intending bidder shall be required to submit/upload (online) the following documents along with their technical bid.
 - a) Bid security declaration to be given in GTE.
 - b) IT returns filed/Annual Report (Balance Sheet and Profit & Loss Account) of last three financial years/any other documents showing Turnover.
 - c) Copies of Work Orders/ Award Letters covering awarded value, detailed scope of work/terms & conditions/ bill of Quantities along with proof of execution/completion certificate as per above Qualifying Requirement. The bidder shall provide the reference list with contact address.
 - d) Firm's documents like Memorandum & Articles of association/ Partnership/ Proprietorship Deed/Certificate of Incorporation etc., with latest changes if any.

8.0 **TENDER OPENING**

- 8.1 First Part of Opening:
 - A) Cover-I (Tender Cost) Tender cost will be opened at 15.00 hours on the day set for submission of tenders.
 - **B)** Cover-II (QR documents / Technical offer) shall be opened on the same day only of the bidders whose Tender cost are found in order.

Note:

- (i) All the supporting documents should be certified / attested by the bidder.
- (ii) In case the bidder fails to submit the documents in support of meeting the qualifying requirements (QR), the offer shall be liable for rejection. Offer of the bidder not fulfilling the QR shall be rejected and their commercial bid shall not be opened.

8.2 **Second Part of Opening:**

Envelope-III: -The commercial bids of only those parties shall be opened who meets Qualifying requirements and specifications. It shall be opened on a fixed date which will be intimated separately to only those parties who qualify in line with the qualifying requirements & specifications.

- 9.0. APCPL reserves the right to assess the capability and capacity of the bidders. Intending parties are advised to visit the APCPL/IGSTPP site to familiarize themselves with nature and quantum of work and site conditions.
- 10.0. The bidders meeting the qualifying requirements (Technically qualified) may be considered for registration/ Enlistment for similar requirements in future for a period of three years.
- 11.0 Tender papers are not transferable.
- Word executed means the bidder should have achieved the progress specified in the QR even if the total contract is not completed/closed and the same shall be supported by the documentary evidence.
- 13.0 The bidder should either be a company Registered under the Companies Act 1956 or a partnership / proprietorship firm.


