5.0 As per provisions of bidding documents, the bidders shall submit "Techno-Commercial Proposal" and "Price Proposal" online (https://eprocurentpc.nic.in/nicgep/app), within the bid submission date and time as mentioned above. Only Techno-Commercial proposals will be opened on the date and timed mentioned in the NTPC-GePNIC Website.

6.0 The date of opening of Price Proposal shall be intimated separately by NTPC after completion of evaluation of Techno-Commercial Proposal.

- **7.0 Tender Fee** shall be submitted online in GePNIC Website only. Any bid without an acceptable Tender Fee shall be treated as non-responsive by the employer and shall not be opened. All credential filled up formats & supporting documents as asked by NTPC are to be given online as attachments with the bid.
- **8.0** Micro and Small Enterprises (MSEs) registered with District Industries Centres or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation(NSIC) or Directorate of Handicrafts and Handloom or Udyog Aadhar or any other body specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit.

The above benefits to MSEs are meant for procurement of only goods produced and services rendered by MSEs. However, traders are excluded from the purview of Public Procurement Policy and not eligible for Benefits to MSEs. Also, benefits under Public Procurement Policy for MSEs shall not be extended in Works Contract.

The bidders are requested to upload Tender Fee/ MSE/ NSIC/ Udyog Aadhar certificate in Fee cover of GePNIC, failing which the bid shall be liable for rejection.

- **9.0** NTPC shall allow purchase preference, as indicated in the bidding documents, to bids from local suppliers as defined in the bidding documents. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- **10.0** A complete set of Bidding Documents may be downloaded by any interested Bidder at our E Tender Site (<u>https://eprocurentpc.nic.in/nicgep/app</u>). For logging on to the E Tender Site, the bidder would require to create user ID and Password as per the Bidder's Manual Kit provided in the aforementioned web site. The payment (non-refundable) of the cost of the documents as mentioned above in the form of a crossed account payee demand draft in favour of NTPC Ltd., Payable at Visakhapatnam shall be submitted in a sealed envelope separately offline by the stipulated bid submission closing date and time at the address given below.

11.0 Qualifying Requirements:

Technical Criteria:

11.1 The bidder should be a manufacturer / authorized dealer of a manufacturer of "Cast Iron Pipes" and should have executed order for supply of 150 NB or above size Cast Iron Pipes.

- 11.2 The bidder should have executed order(s) for "Supply of Cast Iron Pipes" during the preceding seven (07) years, reckoned as on date of technocommercial bid opening with order values meeting any of the following:
 - i. Single order with executed value not less than Rs.98.41 Lakhs.

OR

ii. Two orders with executed value not less than Rs. 61.51 Lakhs each.

OR

- iii. Three orders with executed value not less than Rs. 49.20 Lakhs each
- 11.4 The average annual turnover of the bidder, in the preceding three (03) financial years, reckoned as on the date of Techno-commercial bid opening shall not be less than Rs 123.01 Lakhs (Rupees One hundred twenty three lakhs and one thousand only)

Notes:

- (i) In case where audited results for the last financial year as on the date of Technical bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial year's preceding the last financial year shall be considered for evaluating the financial parameters.
- (ii) For the purpose of arriving at the executed value of work specified at 11.2 above, basic amount only shall be considered. In case of a contract inclusive of Taxes, agency has to provide the break-up of basic value and tax
- (iii) Other income shall not be considered for arriving at annual turnover.
- (iv) The value of the work completed in the preceding seven (07) years reckoned as on date of techno-commercial bid opening, even if it has been started earlier, will only be considered for establishing the qualifying requirements.
- (v) The word "executed" at 11.2 above means; bidder should have achieved the criteria specified in above QR even if the total contract is not completed / closed.
- (vi) In case the bidder is "authorized dealer of a manufacturer", then they should submit tender specific valid authorization from their

principals/ manufacturers and in such case the bidder can furnish their own document or document of principal/manufacturer as documentary proof for qualifying requirement.

- (vii) The bidder should submit the documentary proofs for establishing the QR requirements at 11.0 above.
- **12.0** Notwithstanding anything stated above, the Employer reserves the right to undertake a physical assessment of the capacity and capabilities including financial capacity and capability of the Bidder / his Collaborator(s) / Associate(s) / Subsidiary(ies) / Group Company(ies) to perform the Contract, should the circumstances warrant such assessment in the overall interest of the Employer.

The physical assessment shall include but not be limited to the assessment of the office/facilities/banker's/reference works by the Employer. A negative determination of such assessment of capacity and capabilities may result in the rejection of the Bid.

The above right to undertake the physical assessment shall be applicable for the qualifying requirements stipulated above.

13.0 NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.

14.0 Issuance of Bidding Documents to any bidder shall not construe that bidder is considered qualified.

15.0 Participation in the tender does not automatically mean that the bidders are considered qualified. NTPC shall evaluate the qualifying requirements of each bidder as per NIT after opening of Technical Commercial bids and the bids of the bidder who is not meeting the qualifying requirement shall be treated as non-responsive.
