Qualifying Requirements

In addition to satisfactory fulfilment of the Qualifying requirements stipulated in Section – ITB (Instructions to Bidders) of Bid documents, the following shall also apply:

1.0	TECHNICAL CRITERIA
1.1	Bidder shall submit valid electrical license relevant to the nature of work specified in the tender issued by concerned Authorities. In Case, Bidder does not have valid electrical license, Bidder shall submit an undertaking to submit the same before award of contract.
1.2	The Bidder should have executed similar works within the preceding seven (7) years prior to the date of Techno Commercial Bid Opening
	(i) Executed value not less than Rs.8.28 Crore in a Single Contract
	OR
	(ii) Executed value not less than Rs.5.17 Crore in Two Contracts each
	OR
	(iii) Executed value not less than Rs.4.14 Crore in Three Contracts each
1.3	At least one system cited in credentials for 1.2 above, should be in successful operation for at least One (01) year prior to the date of Techno Commercial Bid Opening
1.4	Similar work means the Scope of Work should include Engineering (either by themselves or by engaging a consultant), supply, installation, testing, commissioning of 11 KV or above rated underground cable works, 11 KV/415 V or above rated transformers, 415 V or above rated switchgears
	Notes for Clause 1.0:
	(i) The word “executed” means the Bidder should have achieved the criteria specified in the qualifying requirements even if the contract has been started earlier and/or is not completed/ closed.
	(ii) Reference work executed by a bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by Project Authority specifying the scope of work executed by the sub-contractor in support of Qualifying Requirements.
2.0	FINANCIAL CRITERIA
2.1	The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, should not be less than ₹ 6.90 Crore (Rs. Six Crore Ninety Lakh only).
	In case a bidder does not satisfy the financial criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company’s Board Resolution as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.
2.2	The Net Worth of the bidder as on the last day of the preceding financial year (reckoned on the date of techno-commercial bid opening) should not be less than 100% of the Bidder’s paid-up share capital. In case the Bidder meets the requirement of Net worth

	based on the strength of its Subsidiary(ies) and/or Holding Company and/or Subsidiaries of its Holding companies wherever applicable, the Net worth of the Bidder and its subsidiary(ies) and/or Holding Company and/or subsidiary(ies) of the Holding Company, in combined manner should not be less than 100% of their total paid-up share capital. However individually, their Net worth should not be less than 75% of their respective paid-up share capitals.
	Net worth in combined manner shall be calculated as follows: Net worth (combined) = $(X1+X2+X3) / (Y1+Y2+Y3) \times 100$, Where X1, X2, X3 are individual Net worth which should not be less than 75% of the respective paid up share capitals and Y1, Y2, Y3 are individual paid up share capitals.
2.3	In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:
	<ul style="list-style-type: none"> a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company. b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated annual financial statements of the Holding Company
	In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practising Chartered Accountant shall be considered acceptable. In case Bidder is not able to submit the certificate from practising Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practising Chartered Accountant certifying the financial parameters is not available.
