1.0 NTPC Limited (NTPC) invites online bids on "Single Stage Two Envelope Bidding basis" from eligible bidders for aforesaid package, as per the scope of supply briefly mentioned hereinafter.

2.0 Brief Scope of Work

Brief Scope of this proposal covers **Procurement of 24V DC Battery Charger for completing pending works of HVAC package at NTPC Kudgi.**

[Kudgi Super Thermal Project is located near village Kudgi, Basavana Begewadi Taluk of Bijapur district in Karnataka].

- 3.0 NTPC intends to finance subject Package through Domestic Commercial Borrowings/ Own sources.

5.0 Bid Security/ EMD

- 5.1 All bidders must submit the "Bid Security Declaration" through GTE [General Technical Evaluation] on online tendering portal, GePNIC.
- 5.2 ANY BID NOT ACCOMPANIED with "Bid Security Declaration" SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.
- 5.3 Micro and Small Enterprises (MSEs) shall be exempt from payment of Tender Fee / Bid Security / EMD.

- 5.3.1 Kindly refer to Clause 4.0 of 'Instructions to Bidders' for detailed Terms and Conditions of "Benefits to MSEs" in this regard.
- 5.3.2 The benefit to MSEs shall be available only for Goods/Services produced & provided by MSEs.

6.0 Qualifying Requirements

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

6.1 Technical Criteria

6.1.1 The bidder should have supplied & commissioned "24V DC Battery Charger with Ni-Cd battery for PLC system with capacity not less than 35Amp" in the preceding seven (07) years, reckoned as on date of techno-commercial bid opening with executed values meeting any of the following:

Single order of value not less than Rs 58.94 Lakhs.

OR

Two orders of value not less than Rs 36.84 Lakhs each.

OR

Three orders of value not less than Rs 29.47 Lakhs each.

6.2 Financial Criteria

6.2.1 The average annual turnover of the bidder, in the preceding three (03) financial years, reckoned as on date of techno-commercial bid opening shall not be less than Rs 73.67 Lakhs (Rupees Seventy-three lakhs and sixty-seven thousand only).

6.3 Notes:

- 6.3.1 In case where audited results for last financial year as on date of techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO/Proprietor/Partner that the financial results of the company are under audit as on date of techno-commercial bid opening and the certificate from practicing Chartered Accountant certifying the financial parameters is not available.
- 6.3.2 For the purpose of arriving at the executed value of work specified at 6.1.1 above, basic amount only shall be considered. In case of a contract inclusive of Taxes, agency has to provide the break-up of basic value and tax.
- 6.3.3 Other income shall not be considered for arriving at annual turnover.
- 6.3.4 The value of work completed in the preceding seven (07) years reckoned as on date of techno-commercial bid opening, even if it has been started earlier, will only be considered for establishing the qualifying requirements.

- 6.3.5 The word "executed" mentioned at clause 6.1.1 above means; bidder should have achieved the criteria specified in the above QR even if the total contract is not completed / closed.
- 6.3.6 The bidder should submit the documentary proof for establishing the QR requirements at 6.1 and 6.2 above.
- 7.0 Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities of bidder and capacity of the Bidder/ his collaborators / associates/ subsidiaries/ group companies for carrying out the supplies and the decision of NTPC in this regard shall be final.
- 8.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 9.0 A complete set of Bidding Document may be downloaded by any interested Bidder from https://eprocurentpc.nic.in. Tender fee as mentioned above shall be paid online through etendering portal GePNIC.

Prospective bidders are compulsorily required to provide GSTIN number along with Tender Fee.

- 10.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening. Bidder shall furnish Cost of bidding document, Bid Security and Power of Attorney separately offline as detailed in Bidding Documents by the stipulated bid submission closing date and time at the address given below.
- 11.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
