\* **Micro and Small Enterprises (MSEs)** registered with District Industries Centers (DICs) or NSIC or Khadi & Village Industries Commission (KVIC) or Khadi & Village Industries Board (KVIB) or Coir Board or Directorate of Handicrafts and Handloom or Any other body specified by Ministry of Micro, Small & Medium Enterprises (M/o MSME) having Udyam Registration, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit.

**I. Qualifying Requirements**

1.	The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfil the following Qualifying Requirements:
1.1	<b><u>Technical Criteria</u></b>
1.1.1	The bidder must be a manufacturer or an authorised agent of the manufacturer for supply and installation of AERB approved 16 Slice CT Scan Machine.
1.1.2	Documentary evidence in support of AERB Certification must be submitted along with the bid.
1.1.3	The manufacturer must have a service center in India.
1.1.4	The bidder should have executed contract for supply and installation of AERB approved 16 Slice CT Scan Machine in the preceding seven (07) years prior to the date of techno-commercial bid opening meeting the following criteria:

	<p>I. Executed value not less than Rs 136 lakh in a Single Contract. OR II. Executed value not less than Rs 85 Lakh each in Two Contracts. Or III. Executed value not less than Rs 68 Lakh each in Three Contracts.</p>
<b>Notes for Clause 1.1.4:</b>	
<b>Note I</b>	The word “executed” means the bidder should have achieved the criterion specified in the QR, even if the total contract(s) is not completed / closed. In case of contract(s) under execution as on date of techno commercial bid opening, the value of work executed till such date will be considered provided the employer certifies the same.
<b>Note II</b>	For the purpose of arriving at the executed value of work specified at 1.1 above, Basic amount only shall be considered. In case of contract inclusive of taxes, agency has to provide the break-up of basic value and taxes.
1.2	<b><u>Financial criteria</u></b>
1.2.1	The average annual turnover of the bidder, in the preceding three (3) financial years as one date of Techno-Commercial bid opening, shall not be less than <b>Rs 170 Lakh (Rupees One Crore Seventy Lakh Only)</b> .
1.2.2	<p>In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following further documents on substantiation of its qualification:</p> <ul style="list-style-type: none"> <li>• Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.</li> <li>• A certificate from the CEO/CFO of the Holding Company as per the format enclosed in the bid documents stating that the unaudited unconsolidated financial statements form part of the consolidated annual report of the company.</li> </ul>
1.2.3	In case where audited results for the last financial year as on the date of Techno Commercial Bid Opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial Bid Opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
<b>Notes</b>	(i) Other income shall not be considered for arriving at annual turnover.

1. Techno Commercial Bid Opening date shall be first scheduled Techno Commercial Bid Opening Date.
2. Bidder should have a separate valid GST registration number and PAN Number.

3. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators/ associates/ subsidiaries/group companies to perform the contract should the circumstances warrant such assessment in the overall interest of the Employer.
4. A complete set of Bidding Document may be downloaded by any interested Bidder from <https://eprocurrentpc.nic.in>. Tender fee as mentioned above shall be paid online through e-tendering portal GePNIC.

d)	Copy of profit and loss account and balance sheet for preceding three (3) completed financial years a son date of bid opening.
e)	Copy of Power Attorney of authorized signatory.
f)	Other relevant documents in support of qualifying requirements.
