### Section-I: Eol Information

#### 1.0 ABOUT NTPC

NTPC is India's largest energy conglomerate with +66 GW power generating capacity, with roots planted way back in 1975 to accelerate power development in India. Since then, it has established itself as the dominant power major with presence in the entire value chain of the power generation business. From fossil fuels it has forayed into generating electricity via hydro, nuclear and renewable energy sources. #### 3.0 PURPOSE OF THE EOI

NTPC intends to capture  $CO_2$  from the waste flue gas exiting Fossil Fired Power Plants and convert it into value added products. NTPC has worked in the domain of  $CO_2$  capture and considers it as a commercially viable with  $CO_2$  utilization. With this intent, NTPC intends to map various upcoming innovative  $CO_2$  utilization technologies and setup demonstration plant of appropriate size. This EoI is for synthesis of carbon in different morphologies (any one or mix of more than one morphology) like high purity carbon, carbon black, carbon fibre, blend of carbon black and carbon fiber, carbon nano tubes etc by utilizing  $CO_2$  separated from flue gas.

After identifying the Indian/ Global Company/ Consortium/ Affiliates/ Representatives (herein after called APPLICANT), contractual and commercial proposals for undertaking Demonstration Project(s) in some of the NTPC plants shall be initiated separately.
