1.0 NTPC Limited (NTPC) invites online bids on "**Single Stage Two Envelope Bidding basis**" from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

#### 2.0 BRIEF SCOPE OF WORK

- a. The To deploy a Medical Mobile Unit on Build, Own and Operate basis.
- b. To provide quality healthcare services as envisaged in in thescope of work.
- c. To deploy medical, paramedical, and other staff for operating the MMU and providing the specified services
- d. To provide healthcare services (consultation with doctor for preventive, curative treatment and free medicines) in the project affected villages (PAVs) of NTPC Mouda.
- e. To provide maternal and child healthcare as per Maternal and Child Healthcare (MCH) policy of NTPC
- antenatal/ prenatal & postnatal preventive healthcare to expectant & new mothers and new born babies & infants to effect reduction in Maternal MortalityRate (MMR) and Neonatal Mortality Rate (NMR)/ Infant MortalityRate (IMR) in project affected villages (PAVs) of NTPC Mouda. Refer to appendix 1 for detailed scope of work of MCH.
- f. To run Behavior Change Communication (BCC) and Information Education Communication (IEC) campaigns.
- g. To operate and maintain all medical equipment and MMU in accordance with the user manuals and ensure the safety and security of the MMU and equipment.
- h. To maintain the MMU in a clean and safe condition.
- i. To keep the MMU and its equipment covered under comprehensive maintenance contracts for the entire contract period
- j. To implement monitoring, reporting and evaluation plan.

NTPC intends to finance subject Package through Domestic Commercial Borrowings/Own sources

4.0 All bids must be accompanied by Tender Fee for an amount of INR 2655.00 (Rupees Two Thousand Six Hundred and Fifty Five only) in the form as stipulated in the Bidding documents. Tender Fee shall be submitted in a sealed envelope separately in physical form/Online Payment by the stipulated bid submission closing date and time at the address given below.

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE TENDER FEE IN A SEPARATE SEALED ENVELOPE/ ONLINE PAYMENT SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

Option for Online payment of tender fee is also made available at GePNIC/e tender portal. Bidders are requested to please avail the facility.

# 5.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirementsstipulated hereunder:

# **5.1** Technical Criteria:

- **5.1.1** Bidder should have its registered office in India.
- **5.1.2** Bidder should be in existence for at least 05 years as on the date of techno-commercial bid opening.
- 5.1.3 The bidder should have executed the work of deployment of Mobile Medical Unit along with Doctor with medical support staff (Nurse, paramedical staff / compounder /pharmacists) with Central Govt. / State Govt. / Union Territory / Semi Govt. / Municipal Corporation / Panchayat / Central Govt. PSU / State Govt. PSU / Govt. Registered NGO / Govt. Establishment / Corporates for a minimum period of one year, within preceding Five (5) years prior to the date of Technocommercial bid opening.
- **5.1.4** Bidder should have CSR Registration No., Income Tax No. registered u/s 12A & 80Gand GST no. as on the date of Techno-commercial bid opening.
- **5.1.5** The bidder should have executed the work of Deployment of Mobile Medical Units along with doctor and medical support staff, within preceding Seven (7) years prior to the date of Technocommercial bid opening, in any of the followingmanner
  - a) One (1) order having executed value not less than Rs **119** Lakh OR
  - b) Two (2) orders having executed value not less than Rs **74** Lakh each
  - c) Three (3) orders having executed value not less than Rs **59** Lakh each.

# Notes:

- 1. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 2. In case of orders under execution, the value of work executed till the date of Technocommercial bid opening duly certified by bidder's client shall be considered acceptable.
- 3. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main Contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements

#### 5.2 Financial criteria:

- 5.2 1 The average annual turnover of the Bidder, shall not be less than **Rs 37 Lakh (Rupees Thirty Seven Lakh only)** during the preceding three (3) completed financial years as on the date of Techno-commercial bid opening.
- 5.2 2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 5.2.1 above on its own, its holding company would be required to meet the stipulated turnover requirements atCl. 5.2.1 above, provided that the net worth of such holding company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of theholding company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the holding company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditionaland irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 5.2 3 In case the bidder is not able to furnish its audited financial statements on stand-alone entitybasis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents in substantiation of its qualification.
  - 1. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.
  - 2. A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bid documents, stating that the unaudited unconsolidated financial statements of the bidder form part of the audited Consolidated Annual Report of the holding company.
- 5.2 4 In cases where audited results for the last financial year as on the date of techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

### NOTES:

- a) Other income shall not be considered for arriving at annual turnover.
- b) "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.
- **6.0 Class-I local suppliers**'/ 'Class-I local suppliers and Class-II local suppliers" only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

OR

Bids from 'Class-Hocal suppliers' as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPHT shall be eligible for purchase preference. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

**7.0** Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- 8.0 Benefits to MSE bidders are applicable for this work. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- 9.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 10.0 A complete set of Bidding Document may be downloaded by any interested Bidder from https://eprocurentpc.nic.in/nicgep/app.

Tender fee (in case of offline payment) as mentioned above is required to be submitted in separately sealed envelope at the address mentioned in the bidding document before stipulated date & time of submission of bid.

- 11.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening. Bidder shall furnish Cost of bidding document and Power of Attorney separately offline/online as detailed in Bidding Documents by the stipulated bid submission closing date and time at the address given below.
- 12.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
