## INSTRUCTIONS PERTAINING TO THE ENLISTMENT OF PAF AGENCIES

1. NTPC Limited, Darlipali STPP hereby intends to go for Enlistment of Project Affect Families (PAF) Agencies for Package pertaining to “Hiring of different types Vehicles” for a period of two years from the date of referred press notification. The agencies who would submit their expression of interest along with requisite documentation would be considered for this proposed Enlistment of Agencies
2. Only the agencies enlisted in this “Enlistment of Agencies for different categories of vehicle” would be considered for issue of tender enquiry for the prevailing requirement of vehicle for NTPC Limited Darlipali STPP.
3. CATEGORIES OF VEHICLES TO BE CONSIDERED FOR SUBJECT ENLISTMENT, STANDING PREFERENCE & MODALITY of AWARD, Formats for Expression of Interest for different categories of vehicles considered for hiring cases at DSTPP are attached herewith. The interested PAF agencies for the subject enlistment are requested to read the said documentations carefully and submit their expression of interests **at the earliest** for the respective category of vehicle for consideration of NTPC for the purpose of “Enlistment of Agencies for different categories of vehicle”
4. Interested PAF agency’s are required to submit their expression of interest as per the NTPC format manually/speed post/through mail in R&R department of NTPC Darlipali ((below mention address for communication).
5. It may be noted that Enlistment shall be done for following categories of Vehicle

Sl no	Categories of vehicles	Type of vehicle
1	CATEGORY-I	JEEP NON AC / AC DIESEL ENGINE JEEP, SUCH AS BOLERO (MAHINDRA & MAHINDRA) OR TATA SUMO (TATA MOTORS) OR EQUIVALENT VEHICLE, ON 12 HRS and 24 HRS DEPLOYMENT BASIS.
2	CATEGORY- II	SPECIAL VEHICLE AC TYPE VEHICLE, SUCH AS SCORPIO (MAHINDRA & MAHINDRA), SWIFT DZIRE (MARUTI), INNOVA (TOYOTA), ANY TYPE OF AC CAR, AC OR NON-AC AMBULANCE, ON 12 HRS and 24 HRS DEPLOYMENT BASIS.
3	CATEGORY-II	AC OR NON-AC BUS, ON 12 HRS and 24 HRS DEPLOYMENT BASIS.
4	CATEGORY-IV	PICK UP, MINI TRUCK, TRACTOR, ON 12 HRS and 24 HRS DEPLOYMENT BASIS.

6. The vehicles shall be allotted among the enlisted PAFs on following priority basis.
  - (i) Category A: (Land +Home stead) outsees would be considered at 1st priority (weightage on the basis of areas of land acquired)
  - (ii) Category B: (Homestead) Oustees would be considered as 2nd priority
  - (iii) Category C: Land Outsees would be considered as 3rd priority.
  - (iv) If PAFs falls in same category , the preference shall be as per date of birth of vehicle owner according to PAN/DL/Adhar Card/10<sup>th</sup> Cetrificate.
7. There would not be any dead line for issue of Letter of Intimation or submission of Expression of interest and the procedure for the enlistment would continue and remain valid for/up to a period of two years from the date of press notification. However NTPC Limited,Darlipali STPP reserves all the rights to AMEND the validity/duration of the proposed FRESH ENLISTMENT as and when required.
8. The first list of enlisted agencies for different categories would be finalized considering the valid Expression of Interest received up to 21 days from the date of press notification . The said list of enlisted agencies would be modified/amended based on the valid Expression of Interest received even beyond the DATE (21) days from the date of press notification) in every six months.Tender enquiry for prevailing requirement of vehicle/s would be floated amongst the latest updated list of enlisted agencies of the respective categories.
