4.1	<u>Technical Criteria</u>
4.1.1	<p>The bidder should have executed /completed the “Work of Installation and Commissioning of Voltage Level 11 kV or above overhead lines ”, during the last seven (07) years prior to the date of Techno-commercial bid opening as per the following criteria:</p> <p>a) Executed value not less than Rs. 442 Lakh in a single order.</p> <p>OR</p> <p>b) Executed value not less than Rs. 276 Lakh each in two orders.</p> <p>OR</p> <p>c) Executed value not less than Rs. 221 Lakh each in three orders.</p>
Note-1	<p>Notes for clause 4.1.1 above:</p> <p>The word “executed” means the bidder should have achieved the criterion specified in the Qualifying Requirements, even if the total contract is not completed/ closed.
