**ANNEXURE-I**  
**Qualifying Requirements**

In addition to satisfactory fulfilment of the Qualifying requirements stipulated in Section – ITB (Instructions to Bidders) of Bid documents, the following shall also apply:

**Qualifying Requirements for Bidders:.**

**QUALIFYING REQUIREMENTS for Supply Installation & Commissioning of 150cum/day STP at CISF and fire colony, KSTPS.**

1.0 The bidders who wish to participate in the bidding shall satisfactorily establish that they fulfill the following Qualifying Requirements.

**1.1 Technical Criteria**

**1.1.1**

The bidder should have executed contract for Design, Engineering, Supply, Erection & Commissioning of Sewerage Treatment Plant (STP) / Effluent Treatment Plant (ETP), of Capacity 1000 KLD or higher, as per the following during the preceding seven (07) years reckoned as on the date of techno-commercial bid opening:

- I. Executed value not less than Rs.224 Lakh in a Single Contract.  
OR
- II. Executed value not less than Rs.140 Lakh each in Two Contracts.  
OR
- III. Executed value not less than Rs.112 Lakh each in Three Contracts.

**Note-1:** Notes for Clause 1.1.1:

The word "executed" means the bidder should have achieved the criterion specified in the QR, even if the total contract(s) is not completed/closed. In case of contract(s) under execution as on the date of techno commercial bid opening, the value of work executed till such date will be considered provided the employer certifies the same.

**Note-2**

For the purpose of arriving at the executed value of work specified at 1.1.1 above, Basic amount only shall be considered. In case of contract inclusive of taxes, agency has to provide the break - up of basic value and taxes.

**2.2 Financial Criteria**

2.2.1 The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, shall not be less than ₹ **140 Lakhs** (Rupees One Crore Forty Lakh only).

2.2.2 In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder furnishes the following further documents on substantiation of its qualification:

- Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company.
- A certificate from the CEO/CFO of the Holding Company as per the format enclosed in the bid documents stating that the unaudited unconsolidated financial statements form part of the consolidated annual report of the company.

2.2.3 In case where audited results for the last financial year as on the date of Techno Commercial Bid Opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-Commercial Bid Opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes: Other income shall not be considered for arriving at annual turnover.

1. Power of Attorney: Bidder also have option to upload scanned copy of the Power of Attorney of the Bidder / Collaborator(s) / JV partners, as applicable, along with the Authority of the person issuing the Power of Attorney, along with the bid on the GePNIC / e-tender portal.
