I. NTPC invites on-line bids on **Single Stage Two Envelope Bidding basis** (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders for “CONSTRUCTION OF TENNIS COURT, BASKET BALL COURT, BADMINTON COURT in PTS , NTPC- TELANGANA” as per Scope of Work mentioned hereinafter.

II. **Brief Scope of Work**

CONSTRUCTION OF TENNIS COURT, BASKET BALL COURT, BADMINTON COURT in PTS, NTPC- TELANGANA

The detailed scope and description of work covered under this package has been specified in relevant clause of Detailed Technical Specification.

As per provisions of Bidding Documents, the Bidders shall submit “Techno-Commercial Proposal” and “Price Proposal” online (<https://eprocurementpc.nic.in/nicgep/app>), within the bid submission date and time as mentioned above. Only Techno-Commercial proposals will be opened on the date and time mentioned above.

- IV. All bids must be accompanied by **Tender Fees (Cost of Bidding Documents) and Bid Security Declaration**. Regarding ‘Bid Security Declaration’, Bidders are required to accept General Technical Evaluation (GTE) conditions on-line while submitting their bid.

Any bid without an acceptable Tender Fees (through online payment) and Bid Security Declaration shall be rejected by Employer as being non-responsive and shall not be opened. For details please refer ITB/ BDS Clause.

V. **Qualifying Requirements for Bidders:**

1.0 Technical Criteria:

- 1.1 The bidder should have executed the works of “Development of any sports facilities with vinyl/ synthetic layer finish OR synthetic play courts”, in the preceding seven(07) years ; reckoned as on the date of techno-commercial bid opening, with executed contract value(s) as below:

i) Single contract with executed value not less than Rs. **61.02** lakhs

OR

ii) Two contracts with executed values not less than Rs.**38.14** lakhs each

OR

iii) Three contracts with executed values not less than Rs.**30.51** lakhs each

2.0 Financial Criteria

- 2.1 The average annual turnover of the bidder in the preceding three(03) financial years, reckoned as on the date of techno-commercial bid opening shall not be less than Rs.**76.27** lakhs (Rupees Seventy six lakhs and twenty seven thousand only).

3.0 Notes:

- a) In case where audited results for the last financial year as on the date of techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters.
- b) For the purpose of arriving at the executed value of work specified at 1.1 above, basic amount only shall be considered. In case of a contract inclusive of Taxes, agency has to provide the break-up of basic value and tax.
- c) Other income shall not be considered for arriving at annual turnover.

- d) The value of the work completed in the preceding seven (07) years reckoned as on date of techno-commercial bid opening, even if it has been started earlier, will only be considered for establishing the qualifying requirements.
- e) The word “executed” mentioned at clause 1.1 above means; bidder should have achieved the criteria specified in above QR even if the total contract is not completed / closed.
- f) In case the bidder has executed the work(s) as sub-vendor, then the bidder has to furnish documentary proof of approval from the principle owner for subletting the work(s).
- g) Bids from "Joint Venture/Consortium" shall only be considered if "Joint Venture/Consortium" firm/company is having standalone credential to meet the QR.
- h) The bidder should submit the documentary proof for establishing the QR requirements at 1.0 and 2.0 above.

VA. The reference works whose details have been declared in their bid shall only be considered to ascertain the bidder's compliance to the specified qualifying Requirement (QR).

The Employer at its discretion may seek any clarification and/or documentary evidence only for the reference works as mentioned above. However, no change or substitution of the reference works by new/additional plant for conforming to the specified qualifying Requirement shall be sought, offered or permitted.

VI. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators / associates/ subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.

VII. NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.

VIII. The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the NTPC tender website <https://eprocurementpc.nic.in>. The Bidder would be required to register on the website.

First time users are required to register themselves on NTPC tender website (<https://eprocurementpc.nic.in>) after filling up the required details. Users whose email address has not been linked to a vendor code allotted by NTPC/ first time users not allotted any vendor code by NTPC, should send a copy of the registration details to the e-mail address specified in this NIT under Address for Communication with following details at least three working days prior to Technical Opening Date:

IX. Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.

- X Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
- XI 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- XII Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.
