- 2. Buyer Added text based ATC clauses

1. For getting MSE purchase preference for the entire package, the bidder must be manufacturer of Video Conferencing Camera.

2. **Installation and Commissioning:** Installation & Commissioning shall include installation & commissioning of all equipment under supply. The supply of all installation material required for installation including all Cables and Connectors shall be in the scope of Work of the Supplier.

3. **Warranty:** The bidder shall warranty the equipment for good performance to the satisfaction of the Owner for a period **of 3 years** from the date of acceptance on successful commissioning. During the warranty period, the Bidder shall promptly attend to any number of complaint and get the faulty equipment repaired/replaced in the shortest possible time. Satisfactory working shall be restored within 24 hours of intimation by the Owner. Necessary spares shall be stocked by the Bidder to ensure minimum downtime in case of fault. All materials, parts, services etc., during the warranty period shall be provided free of charge to Owner.

4. **Delivery Period:** Delivery Of equipment's: within 8 weeks of Purchase Order, Installation & Commissioning : 4 weeks after delivery.

5. **Authorization Partner Certificate**:Bids specific OEM authorized certificates confirming warranty clause of 3 years.

6. **Payment terms:** 100% on acceptance by engineer-incharge after installation, commissioning & satisfactory performance.

Bidder may note that in case they do not submit the aforesaid declaration or no confirmation is indicated by them or statement/any declaration like 'later', 'to be furnished later', 'NA' etc. are indicated against the declaration, then the bid shall be rejected by EMPLOYER as being non-responsive and shall not be opened.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid.
