Micro and Small Enterprises (MSEs) registered with District Industries Centers (DICs) or NSIC or Khadi & Village Industries Commission (KVIC) or Khadi & Village Industries Board (KVIB) or Coir Board or Directorate of Handicrafts and Handloom or Any other body specified by Ministry of Micro, Small & Medium Enterprises (M/o MSME) having Udyam Registration, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit.

Detailed specification of material and other terms & conditions are mentioned in the tender documents.

# (I) Qualifying Requirements (QR)

# 1.0 Technical Criteria

The Bidder should have supplied Cooking Appliances including electric/Induction based coking appliances within the preceding seven (07) years prior to the date of techno commercial bid opening, meeting the following criteria:

(i) Single order having executed value of above work not less than ₹89.56 Lakh.

OR

(ii) Two orders having executed value of above work(s) not less than ₹55.97 Lakh each.

OR

(iii) Three orders having executed value of above work(s) not less than ₹44.78 Lakh each.

## 2.0 Financial Criteria

2.1 The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, should not be less than ₹ 111.95 Lakh (Rs. One Hundred Eleven Lakh Ninety-Five Thousand only).

In case a bidder does not satisfy the financial criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.

- **2.2** In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification:
  - (a) Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of its Holding Company.
  - (b) A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated annual financial statements of the Holding Company.

In case where audited results for the last financial year as on the date of techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results for the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

#### **NOTES:**

- (i) Other income shall not be considered for arriving at annual turnover.
- (ii)"Holding Company" and "Subsidiary" shall have the meaning ascribed to them as per Companies Act of India.

- (iii) For Turnover indicated in foreign currency, the exchange rate as on seven (07) days prior to the date of techno-commercial bid opening shall be used.
- (iv) All financial figures mentioned above are exclusive of GST.

### (II) GENERAL TERMS AND CONDITIONS

- 1. A complete set of bid documents may be downloaded by any interested bidder by logging at our site <a href="https://eprocurentpc.nic.in/">https://eprocurentpc.nic.in/</a>. For logging on to our site, the bidder would require user id and password which can be created by themselves at our site from Online Bidder Enrollment tab. First time users, who do not have vendor code in NTPC database are required to approach NTPC at least 05 (Five) working days prior to Bid Submission End Date along with duly filled EFT Forms, Cancelled Cheque, Copy of PAN, Copy of TIN, Copy GST Registration, other documents related to credentials etc.
- 2. Payment of Tender Fee by any bidder shall not construe that such bidder is considered to be qualified.
- 3. Notwithstanding anything stated above, NTPC reserve the right to assess bidder's capability and capacity of the bidder for carrying out the supplies and the decision of NTPC in this regard shall be final.
- 4. NTPC reserves the right to accept or reject any or all the tenders in part or full including rejection of any request for issue of tender documents, alter the quantities or split the order without assigning any reason thereof.
- 5. Bidders have to submit bids on line on the NTPC e- procurement (https://eprocurentpc.nic.in/). Single Stage two envelope bidding system will be followed for the subject package. Technical & Price Bids shall be submitted online before expiry of Bid Submission End Date.
- 6. Envelope-1 (Marked as Tender Fee/Bid Security exemption) shall be opened first and contents of this envelope shall be checked before opening of the Technical Bid/Envelope- 2 (Marked as QR).
- 7. Technical Bid/Envelope-2 (Marked as QR) of only those bidders whose Tender Fee/ Bid Security Declaration are found valid & acceptable, will be opened. If the bidder qualifies as per the QR and terms & conditions of NIT, their price bid shall be opened on the scheduled date as notified in NIT or on the date to be intimated after evaluation of technical bids.

Above details are only indicative. Other detailed terms and conditions shall be as per tender documents.
