Micro and Small Enterprises (MSEs) registered with District Industries Centers (DICs) or NSIC or Khadi & Village Industries Commission (KVIC) or Khadi & Village Industries Board (KVIB) or Coir Board or Directorate of Handicrafts and Handloom or Any other body specified by Ministry of Micro, Small & Medium Enterprises (M/o MSME) having Udyam Registration, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit.

Detailed specification of material and other terms & conditions are mentioned in the tender documents.

2	Qualifying Requirement The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:
2.1	Technical Criteria
2.1.1	The Bidder should be a “manufacturer of Microprocessor Based Electronic Positioners” or “manufacturer’s authorized representative in India for electronic positioners” and the offered Electronic Positioner should be in successful operation for minimum one (1) year prior to the date of Techno-commercial bid opening.
2.1.2	The bidder should have executed the ‘supply of Microprocessor Based Electronic Positioners / transmitters’ to ‘power plants having unit/s of minimum 100MW rating’/ ‘Oil

	<p>refineries' / 'petroleum processing industries' / 'Chemical Industries' within preceding Seven (7) years prior to the date of Techno-commercial bid opening, in any of the following manner-</p> <p>A. One (1) order having executed value not less than Rs 66 Lakh,</p> <p>B. Two (2) orders having executed value not less than Rs 41 Lakh each.</p> <p>C. Three (3) orders having executed value not less than Rs 33 Lakh each.</p>
NOTES	<p>1) The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.</p> <p>2) In case of orders under execution, the value of work executed till the date of Techno-commercial bid opening duly certified by bidder's client shall be considered acceptable.</p> <p>3) Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements</p>
2.2	Financial Criteria
2.2.1	The average annual turnover of the Bidder, shall not be less than Rs 83 Lakh (Rupees Eighty Three Lakh only) during the preceding three (3) completed financial years as on the date of Techno-commercial bid opening.
2.2.2	<p>In case the bidder does not satisfy the financial criteria, stipulated at Cl. 7.2.1 above on its own, its holding company would be required to meet the stipulated turnover requirements at Cl. 7.2.1 above, provided that the net worth of such holding company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the holding company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the holding company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.</p>
2.2.3	<p>In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents in substantiation of its qualification.</p> <ol style="list-style-type: none"> 1. Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the Holding Company. 2. A Certificate from the CEO/CFO of the Holding Company, as per the format

	enclosed in the bid documents, stating that the unaudited unconsolidated financial statements of the bidder form part of the audited Consolidated Annual Report of the holding company.
2.2.4	In cases where audited results for the last financial year as on the date of techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the Company are under audit as on the date of Techno-commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.
NOTES	<ol style="list-style-type: none"> 1) Other income shall not be considered for arriving at annual turnover. 2) "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue. 3) Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
