# 4.0 Brief Scope of Work and other Specific details:

The work comprises comprehensive (with spares) onsite maintenance of window, split type AC units including the voltage stabilizers, freezers, fridge and water coolers installed in PMI Complex at Noida. This includes repair, overhaul, checking, and replacement of defective parts etc. during the contract period.

- 5.0 Downloading / Issuance of bidding documents to any bidder shall not construe that bidder is considered qualified.
- 6.0 'Class-I local suppliers' are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

# 7.0 Qualifying Requirements for Bidders:

- 7.1 The bidder should have completed/ executed any one of the following works in preceding seven(07) years as on the date of techno commercial bid opening, which includes Maintenance work of Air Conditioners installed in India:
  - (a) One completed work having contract value not less than ₹10.95 Lacs
  - (b) Two completed works having contract value not less than ₹6.84 Lacs
  - (c) Three completed works having contract value not less than ₹5.47 Lacs.
- 7.2 The bidder should have an average annual turnover of at least ₹1368800.00 during the preceding three years.

### Note:

While computing the turnover other income shall not be considered.

In cases where audited results for the last financial year as on the date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid

opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

8.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Notice Inviting Tender [NIT] for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
