1.0 INTRODUCTION

NTPC Limited (Established in 1975, formerly known as National Thermal Power Corporation Limited) is an Indian Maharatna Public Sector Enterprise under the Ministry of Power, Government of India. NTPC Ltd. is the largest power generation company with total installed capacity of about 67905 MW (including JVs), located across India comprising of 48 NTPC Stations (23 Coal based stations, 7 gas based stations, 1 Hydro station, 1 small hydro, 15 Solar PV and 1 Wind based Station) and 26 Joint Venture stations (9 coal based, 4 gas based, 8 hydro, 1 small hydro 2 Wind and 2 Solar PV).
