4.0 The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the NTPC tender website <a href="https://eprocurentpc.nic.in">https://eprocurentpc.nic.in</a>.

The Bidder would be required to register in the website. First time users are required to register themselves on NTPC tender website after filling up the required details. Users whose email address has not been linked to a vendor code allotted by NTPC/ first time users not allotted any vendor code by NTPC, should send a copy of the registration details to the e-mail address specified in this NIT under Address for Communication with following details at least three working days prior to Technical Opening Date:

- iii. Copy of PAN no.,
- iv. email ID and Contact No.
- v. Name and Designation of the contact person
- vi. Cancelled cheque & E.F.T form duly verified by bank

## 5.0 Brief Scope of Work & other specific detail

The scope of the work is to provide resources for the CSOC operations. The scope of work also includes Breach Investigation services to provide investigation services in case of a Cyber security breach.

# 6.0 Qualifying Requirements for Bidders:

6.1 The bidder should have a valid ISO-27001/BS 7799 certificate for Security Operations Center (SOC) / Managed Security Service (MSS) as on the date of techno-commercial bid opening.

OR

The bidder should be a cyber-Security auditor empaneled by CERT-In (Computer Emergency response team of India) as per the list available in the CERT-In website.

- The bidder should have executed any one of the following 'Similar' Works in preceding Seven years as on the date of techno-commercial bid opening:
  - a. One Work of value not less than Rs. 110 Lacs

OR

b. Two Works of value not less than Rs. 69 Lacs each

OR

c. Three works of value not less than of Rs. 55 Lacs each.

#### Note:

Similar' work means any work which includes any one or more of the following:

- · Managed Security Services/ Security Outsourcing Services
- · Setting up/supply & installation / operation/ management of Security Operation Center (SOC) Services
- · Management/ implementation of Security Orchestration, Automation and Response (SOAR) solution
- · Management/ implementation of SIEM (Security Information and Event Management) Solution
- · Incident response solution/ services

#### Note:

- 6.2.1 The word "executed" means the bidder should have achieved the criteria specified even if the total contract is not completed / closed. However, work executed should include the any one or more of the "Similar Works" as defined above ,as on the date of Techno-Commercial bid opening.
- 6.2.2 In case of orders under execution, the value of work executed till the date of techno-commercial bid opening as certified by the Employer shall be considered. However, work executed should include the any one or more of the "Similar Works" as defined above, as on the date of Techno-Commercial bid opening.
- 6.2.3 The above value of executed works is exclusive of applicable tax/ GST.
- The average annual turnover of the bidder in the preceding three (03) financial years as on the date of Techno-Commercial bid opening, should not be less than ₹27.46 Lacs (Rupees Twenty Seven lacs Forty Six Thousands)

#### Note:

- 6.3.1 While computing the turnover other income shall not be considered.
- 6.3.2 In case where audited results for the last financial year as on the date of Techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable.

In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno- commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

- **7.0** Issuance of Bidding Documents to any bidder shall not construe that bidder is considered qualified.
- **8.0** NTPC shall allow purchase preference to MSEs.
- 9.0 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT.

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

**10.0** NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
