3.0 Bidder shall accept relevant attribute of GTE of E-tender portal as confirmation to acceptance of provisions of Bid Security Declaration.

The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the NTPC tender website <https://eprocurentpc.nic.in>.

The Bidder would be required to register in the website. First time users are required to register themselves on NTPC tender website after filling up the required details. Users whose email address has not been linked to a vendor code allotted by NTPC/ first time users not allotted any vendor code by NTPC, should send a copy of the registration details to the e-mail address specified in this NIT under Address for Communication with following details at least three working days prior to Technical Opening Date:

- i. Request on the letter head of the Company
- ii. Copy of GST Registration,
- iii. Copy of PAN no.,
- iv. email ID and Contact No.
- v. Name and Designation of the contact person
- vi. Cancelled cheque & E.F.T form duly verified by bank

5.0 Brief Scope of Work & other specific detail

The Bidder will be responsible for provisioning of required cloud infrastructure and services as listed in the Bill of quantity based on NTPC's (owner's) requirement from time to time . The Bidder will examine the application landscape that needs to be hosted on cloud infrastructure. This activity may enable the Bidder to gauge the application workload requirements before provisioning the respective cloud infrastructure / services. Detailed scope of work shall be as per the tender documents.

6.0 Qualifying Requirements for Bidders:

- 6.1 (a) The bidder should be a Cloud service provider (CSP). The cloud service provider should be Ministry of Electronics and Information technology (MeitY) empaneled as on the date of techno commercial bid opening.

OR

(b)The bidder should be Managed service provider (MSP) authorized with a CSP who meets the above requirement.

6.2 The Bidder should have executed any one of the following works which includes providing / managing cloud services in India in the preceding Seven (07) years as on the date of Techno-Commercial bid opening:

a) One work costing not less than Rs 293 Lacs (Rupees Two hundred ninety three lacs only)

OR

b) Two works costing not less than Rs 183 Lacs (Rupees One hundred eighty three lacs only) each.

OR

c) Three works costing not less Rs 147 Lacs (Rupees One hundred forty seven lacs only) each

Note:

2.1 In case of orders under execution, the value of work executed till the date of Techno-Commercial bid opening as certified by the client shall be considered. However, providing /managing of Cloud services must be included in the work executed as per client certificate.

2.2 While calculating executed value of PO, only basic value will be considered. Taxes and duties will be excluded.

6.3 The average annual turnover of the bidder in the preceding three (03) financial years as on the date of Techno-Commercial bid opening, should not be less than Rs 183 lacs (Rupees One eighty three lacs)

Notes for clause 3.0:

3.1. While computing the turnover other income shall not be considered.

3.2. In case where audited results for the last financial year as on the date of Techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable.

In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno- commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

- 7.0** Issuance of Bidding Documents to any bidder shall not construe that bidder is considered qualified.
- 8.0** NTPC shall allow purchase preference to MSEs.
- 9.0** **Only 'Class-I local suppliers' are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT.**

The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
