1. **INTRODUCTION**

- i. NTPC Limited produces around 300 billion units of electricity annually through its cluster of gas, coal, hydro and RE based power stations of more than 67 GW capacity spanning across the country. Further NTPC plans targets RE capacity of 60 GW by 2032.
- i. NTPC Ltd., in keeping focus on power generation in environmentally responsible manner, has already initiated biomass co-firing at its thermal power plants. This is also mandated by the policy as issued & later revised by the Ministry of Power (Government of India) in Oct. 2021 for “Biomass Utilization for power generation through co-firing in Coal based Power Plants”.
- ii. Accordingly NTPC Limited intends to purchase torrefied biomass for its Talcher TPP-III Expansion Project at Orissa, India approximately after 4 years from now of about 4000 Metric Tones per day. In this regard, NTPC Limited invites Expression of Interest (EOI) from any Indian entity. (Hereinafter called APPLICANT). This EOI is to identify prospective entities for the supply of torrefied biomass on sustainable basis as also enable establishing long term supply chain.
- iv. The ultimate objective is to reduce carbon emission of coal fired power plant and simultaneously reducing air pollution by discouraging stubble burning by way of co-firing with coal.

2. **INTENT OF THE EXPRESSION OF INTEREST (EOI)**

- i. NTPC’s conventional coal-based fleet is required to mandatory co-fire biomass towards environment protection as also towards compliance of MoP policy guidelines in this regard.
- i. The above is to be achieved by way of blending of biomass pellets (torrefied only) along with coal.
- ii. The purpose of this EOI is to identify prospective potential entities for the supply of torrefied biomass on sustainable basis and subsequently build long term supply chain. It is intended to co-fire biomass in the Talcher-III expansion project for the complete useful life of the plant.

3. **PREFERENCE:**

- i. The Applicant of the EOI should be any entity capable of supplying torrefied biomass on sustained basis for long term (min. 7 years).
- i. The general specifications for the intended torrefied biomass for future procurement purpose is given at Annexure-A & B. for power generation through biomass co-firing in pulverized coal fired units.
