- 1.0 NTPC Limited (NTPC) invites online bids on "**Single Stage Two Envelope Bidding basis**" from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.
- 2.0 BRIEF SCOPE OF WORK

The brief scope of work covers Reconditioning of Vane Row#1 and Vane Row#2 of Gas Turbine GT13E1, NTPC Jhanor.

NTPC intends to finance subject Package through Domestic Commercial Borrowings/Own sources.

3.0 Detailed Specification, Scope of Work and Terms & Conditions are given in the Bidding Documents, which are available for examination and Sale at our eProcurement Portal (https://eprocurentpc.nic.in/nicgep/app) and as per the following schedule:

"No Queries from Bidders, whatsoever, shall be entertained by the Employer beyond the last date of receipt of Queries/ Pre-Bid Conference (if applicable) as specified above." Corrigendum (if any) shall be available on our e-tender website <u>https://eprocurentpc.nic.in</u> only.

4.0 All bids must be accompanied by **Bid Security Declaration** in the form as stipulated in the Bidding documents. Bid Security Declaration shall be submitted by acceptance of General Technical Evaluation (GTE) Attribute "*Do you accept Bid Security Declaration*" in Gepnic portal.

In case a bidder does not submit the aforesaid declaration, then the bid shall be rejected by employer as being non-responsive and shall not be opened.

Option for Online payment of tender fee is also made available at GepNIC/e tender portal. Bidders are requested to please avail the facility.

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE TENDER FEE SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

- 5.0 **Benefits to MSE bidders are applicable for this work.** The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.
- 6.0 A complete set of Bidding Document may be downloaded by any interested Bidder from https://eprocurentpc.nic.in/nicgep/app. Tender fee (in case of offline payment) as mentioned above is required to be submitted in separately sealed envelope at the address mentioned in the bidding document before stipulated date & time of submission of bid.

Prospective bidders are compulsorily required to provide GSTIN number with Tender Fee.

7.0 QUALIFYING REQUIREMENTS FOR BIDDERS.

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

7.1 Technical Criteria

7.1.1 PROVEN EXPERIENCE

The bidder should be a 'Gas Turbine manufacturer'/ 'Manufacturer of Gas Turbine blades or vanes'/'Refurbishment agency of the Gas Turbine blades or vanes' and should have 'carried out'/ 'got carried ouť refurbishment and coating/manufacture of at least one(01) set of Stage-I or II air cooled coated blades or vanes for Gas Turbines having minimum rating of 98 MW ISO at Turbine Inlet Temperature(TIT) of 990 Deg C minimum, which should have completed successful operation of at least one Hot gas Path inspection or Major Overhaul (Minimum 15000 EOH) prior to the date of techno-commercial bid opening.

7.1.2 Specific Plant related technology and capability

The bidder must either himself possess or have legitimate access for the necessary technology of refurbishment/coating of air-cooled coated and non-coated Blades/Vanes of Gas Turbine having ISO rating of 147MW at Turbine Inlet Temperature (TIT) of 1070 Deg C.

The Bidder at his option can also outsource any of the activities required for refurbishment/Coating of the above Blades /Vanes subject to the condition that the chosen outsourcing agency by the bidder also has the necessary technology of outsourced activity of refurbishment/coating of air-cooled coated and non-coated Blades/Vanes of Gas Turbine having ISO rating of 147MW at Turbine Inlet Temperature (TIT) of 1070 Deg C.

7.1.3 The bidder can be Licensee or Authorized agent of 'Gas Turbine Original Equipment Manufacturer' (OEM) / 'Manufacturer of Gas Turbine blades or Vanes' / 'Refurbishment agency of the Gas Turbine blades or vanes'. In such case, the bidder can be considered qualified based on the experience of their Principal, who meets the requirements mentioned above in para 7.1.1 and 7.1.2.

7.1.4 The bidder, should have executed the similar Work within preceding seven (07) years prior to the date of Techno-commercial bid opening, in any of the following manner:

a) One (1) order having executed contract value not less than **Rs. 313 Lakh** or equivalent in foreign currency.

OR

b) Two (2) orders having executed contract value not less than **Rs. 196 Lakh** each or equivalent in foreign currency.

OR

c) Three (3) orders having executed contract value not less than **Rs. 157 Lakh** each or equivalent in foreign currency.

Notes for Technical Criteria:

- In case bidding is done by be Licensee or Authorized agent of 'Gas Turbine Original Equipment Manufacturer' (OEM) / 'Manufacturer of Gas Turbine blades or vanes' / 'Refurbishment agency of the Gas Turbine blades or vanes', evaluation of the similar work executed as per clause 7.1.4 can be done on the basis of credentials of the principles of Licensee or Authorized agent.
- 2. The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- 3. In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 4. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified

by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.

- 5. For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break –up of basic value and taxes.
- 6. Similar work means refurbishment of Gas Turbine Hot Gas Path Components.
- 7. The bidders have to submit the details available with them or with their outsourcing agency in support of qualifying requirement.
- 8. General Requirement : NTPC has the right to assess the capability and capacity of the bidder for carrying out the refurbishment of the air-cooled blades/vanes of 13E1 type of ABB (now GE) make machines of Jhanor Gandhar Gas Power Project.
- 9. In case, bidder has executed reference work under two orders one for supply and one for services separately for the same installation, combined value of both the orders shall be considered as a single order for the purpose of evaluation.

7.2 Financial Criteria:

7.2.1 The Average Annual Turnover of the Bidder, should not be less than **Rs.391 Lakhs (Rupees Three crore ninety one lakh only**) or equivalent in foreign currency during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.

7.2.2 In case the bidder does not satisfy the financial criteria, stipulated at Cl. 7.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 7.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.

7.2.3 In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

• Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

• A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.

7.2.4 In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 7.2:

- i. Other income shall not be considered for arriving at annual turnover.
- ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- iii. Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- 8.0 Class-Hocal suppliers'/ 'Class-I local suppliers and Class-II local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

OR

Bids from 'Class-I local suppliers' as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT shall be eligible for purchase preference. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids."

9.0 Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

10.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.

- 11.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- 12.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
