Expression of Interest for Transportation, Unloading & disposal of Fly ash from NTPC Vindhyachal to Gorbi Mines.

- 1. NTPC Vindhyachal invites Expression of interest (EOI) for Transportation, unloading & disposal of Fly ash, generated from NTPC Vindhyachal thermal power plant Located at Vindhyanagar, Singrauli, Madhya Pradesh.
- 2. The purpose of inviting this EOI is to seek interest from Transporting agencies, for fly ash transportation to Gorbi Mines by RCR (Rail cum Road) Mode on long term basis.
- 3. After evaluating the response(s) received in this EoI, further modalities for work allocation / award of work will be done as per NTPC Works &Procurement Policy through transparent bidding / tendering process.
- 4. **Eligibility for Participation in EOI**: Government / Private Transporting Agencies or Container Train Operators (CTOs).
- 5. **Download and Submission of EOI**: Interested agencies may download the documents of EOI free of cost from NTPC website: **www.ntpctender.com**
- 6. All Participants shall ensure that their EOI application is complete in all respects.
- 7. NTPC Vindhyachal reserves the right to reject or accept any or all applications, cancel / withdraw the EOI process without assigning any reason whatsoever and in such case, the participants shall not have any claim in this regard.

Section II Information to Participants

NTPC Limited

(A Govt. of India Enterprise)

1. <u>Introduction of NTPC Vindhyachal</u>: Vindhyachal STPP is a pit head coal based super thermal power plant of total capacity 4760 MW established in five Stages viz. Stage-I, II, III, IV & V. The station comprises of six units of 210 MW (Stage-I), two units of 500MW each of Stage-II, III and IV and one unit of 500MW of Stage-V, all units are under commercial operation. NTPC Vindhaychal daily average ash generation is approx.. 24000 MT/day. The plant is located in Singrauli district of Madhya Pradesh, having a latitude and longitude of 24° 6' N and 82° 40' E respectively.


<u>Introduction of Gorbi-Pit</u>: Gorbi pit void is the abandoned coal mine of Northern Coalfields Limited located in Singrauli District of Madhya Pradesh, having a latitude and longitude of 24°13′08.63N & 82°34′51.49E respectively, situated at approximately 40 Kms from NTPC-VSTPS by Road. <u>Northern Coalfields Limited (NCL)</u> has provided the Gorbi coal mine pit to NTPC Vindhyachal Super Thermal Power Station for backfilling by fly ash. Nearest Railway station to Gorbi Pit-I is Mahdeiya (MHDA), at a distance of approximately 2 km from Gorbi pit.

2. Scopeof Work:

- 1) The work broadly comprises of **Five** components, which are:
 - a) <u>Collection of Ash from VSTPP Plant</u>: Collection of Dry Fly ash in Technically and Statutorily suitable containers from VSTPS Plant which can be **either** from
 - i) "The Silos of Stage 1 and / or Stage 4 (which have rail loading facility)", called "Source 14" hence forth in this document, or,
 - ii) "The Silos of Stage 2 and/or Stage 3 and / or Stage 5 (which do not have rail loading facility)", called "Source 235" henceforth in this document.
 - b) Preparatory works to dispatch from Railway Siding:
 - i) In case of collection from Source 14: Loading the filled up containers on to Rail Rakes (to be arranged by the Participants) at VSTP siding, or,
 - ii) In case of collection from Source 235:To transport the filled-up containers on Road trailers (Participant arranged)initially up to VSTP siding and then to load them on to Participant arranged Rail Rakes at VSTP Railway Siding.
 - c) **Transportation thru Railways**, of above loaded rakes from VSTPS to a Railway station nearest to Gorbi mines in liaison with Indian Railways
 - d) **Unloading on to Road trailers and Transportation** of above containers from the above railway station to the Gorbi Unloading Platform area, and,
 - e) **Disposal arrangement and Operation of the system:** Setting up a properly designed, Technically and environmentally safe arrangement at the Gorbi unloading platform for smooth and convenient disposal of the ash brought from VSTPS after converting the same into slurry form into identified area of the Gorbi pit for the purpose of mine filling.
- 2) Compliance with Railway norms in respect of safety and free time allowed as well as all applicable statutory and environmental norms in all the activities undertaken.
- 3) Participants can refer to the illustrative map enclosed. It is recommended that they may also visit all the locations mentioned prior to submission of their application.
- 4) Water for slurry preparation is available in the Gorbi mine pit, which is of pH 3.4 approx.
- 5) 01 rake/ 3000 MT to be disposed every day/10 lakhs MT per year.

- 6) It is planned to have contract for five years initially.
- 7) Arrangement of Truck trailers, Railway rakes, Customization of containers for ash loading and evacuation, System design and construction of ash disposal system in slurry form, Reachstaker/crane/Any other Machinery/Structure, Water/Slurry Pumps, blowers/compressors, Piping, Liasioning with Railways, Pollution control authorities, providing experienced O & M manpower shall be in the scope of agency including all capital expenditure.
- 8) Provision of Material Handling and Lifting Equipment, as may be required for handling and transportation of inventory/spare parts/equipment within fields asset as per the company's Health, Safety and Environment (HSE) policy& applicable Road Transport standards, shall also be in agency's scope.
- 9) Space / land required for the System to be established near Gorbi mine by the Participant shall be indicated by the participant so that NTPC can consider its arrangement.
- 10) Participants shall also indicate their power supply requirements at Gorbi pit area so that NTPC can consider its arrangement.
- 11) While NTPC shall obtain the Consent to establish, Consent to operate with regard to the system to be established at Gorbi Pit area and the Permission to fill the Mine etc, the participant shall also be required to facilitate and liaison with the concerned authorities for the same.
- 12) The total Operation should be carried out in Environment friendly manner without any ash leakage. Any special technology solution provided by the agency can be mentioned separately.

- ➤ Participants shall submit documentary evidence in support of their experience in this field of work.
