Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY.

3. 1.0 NTPC Limited (NTPC) invites online bids on “ **Single Stage Two Envelope Bidding Basis**” from eligible bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

2.0 **BRIEF SCOPE OF WORK**

The scope of the proposal for shall be **Procurement of Condenser tubes for NTPC Singrauli** on the basis of single point responsibility completely covering the activities and services in respect of all the equipment & works specified and covered under the specifications and read in conjunction with “**Scope of Supply**” elaborated elsewhere.

3.0 **QUALIFYING REQUIREMENTS FOR BIDDERS.**

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

3.1 **Technical Criteria:**

3.1.1 The bidder should be a manufacturer of turbine condenser for power plants and should have supplied at least 1 no. turbine condenser for unit capacity of at least 100MW, which should have been in successful operation for at least one (1) year prior to the date of Techno-Commercial bid opening.

Or

3.1.2 The bidder should have manufactured and supplied ‘Cu-Ni tubes/pipes’ to any industry prior to the date of techno-commercial bid opening, meeting the following criteria:

(i) Single order of value of above work not less than **Rs 532.22 Lakhs.**

OR

(ii) Two orders of value of above work(s) not less than **Rs 332.64 Lakhs** each.

OR

(iii) Three orders of value of above work(s) not less than **Rs 266.11 Lakhs** each.

Notes:

1. All values above are exclusive of GST/Taxes.

2. Bidder(s) seeking qualification under clause 3.1.1 above shall be deemed / considered to have met the criterion under clause 3.1.2 stipulated above. However in case they bid for the tender they shall have to qualify financial criterion stipulated in this qualifying requirements.

Note for Clause 3.1:-

The word "Executed/Supplied" means the Bidder should have achieved the criteria specified in the qualifying requirements at Clause 3.1, even if the contract has been started earlier and/or is not completed/closed.

Financial Criteria:

3.1.3 The average annual turnover of the Bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening, should not be less than **Rs. 665.28 Lakhs (Rupees Six Crore Sixty Five Lakhs and Twenty Eight Thousand Only)**.

3.1.4 In case a bidder does not satisfy the financial criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.

3.1.5 In case the bidder is not able to furnish its audited financial statements on stand-alone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

A Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated annual financial statements of the Holding Company.

- 3.1.6 In cases where audited results for the last financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes:-

1. Other income shall not be considered for arriving at annual turnover.
2. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India.

- 4.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Invitation for Bids/NIT without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
- 5.0 Issuance of bid documents to any Bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- 6.0 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.
