1. NTPC invites on-line bids on Single Stage Two Envelope Bidding basis (Envelope-I: Techno-commercial Bid & Envelope-II: Price Bid) from Eligible Bidders for aforesaid package, as per the scope of work briefly mentioned hereinafter.

2. Brief Scope of Work

Brief scope of this proposal covers following: -

RLA and Refurbishment of Mixing Chambers of Siemens V 94.2 Gas Turbine is to be carried out as per MAC-33 requirements

NTPC intends to finance subject Package through Domestic Commercial Borrowings/Own sources.

Only Techno-Commercial proposals will be opened on the date and timed mentioned above.

4. All bids must be accompanied by Tender Fees (Cost of Bidding Documents submitted through online portal only) and Integrity Pact(if applicable). Integrity Pact shall be submitted as per instruction mentioned in ITB/ SCC.

Any bid without an acceptable Tender Fees (through online payment) and Integrity Pact(**if applicable**) shall be rejected by Employer as being non-responsive and shall not be opened.

5. All bids must be accompanied by **BID SECURITY for an amount (as mentioned at Clause 3.0 above)**.

"ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE BID SECURITY IN A SEPARATE SEALED ENVELOPE (ONLY IN CASE WHERE SECURITY BID IS SUBMITTED THROUGH BG) SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED. IN CASE, THE BID SECURITY IS SUBMITTED THROUGH ELECTRONIC FUND TRANSFER (EFT), BIDDER TO SUBMIT THE PROOF OF E-PAYMENT OF BID SECURITY EITHER IN SEPARATE SEALED ENVELOPE OR IN THE E-TENDERING PORTAL."

Any bid without an acceptable Tender Fees (through online payment), Bid Security (online or BG) and Integrity Pact(**if applicable**) shall be rejected by Employer as being non-responsive and shall not be opened.

6. Qualifying Requirements for Bidders:

The bidder who wishes to participate in the bidding shall meet the Qualifying Requirements stipulated hereunder:

6.1. Technical Criteria:

6.1.1 The bidder should be a Gas Turbine manufacturer/ Manufacturer of Gas turbine sheet metal hot path components/ Refurbishment Agency of Gas Turbine sheet metal hot path components. The bidder should have carried out/ got carried out manufacturing/ refurbishment of at least two (02) nos. of the afore-mentioned components of Silo type of gas turbines having minimum rating of 98MW ISO at Turbine Inlet Temperature of 990 Deg C minimum, which should have completed successful operation of at least one hot gas path inspection or Major Overhaul.

AND

6.1.2 Bidder must either himself possess or have legitimate access for the necessary technology of refurbishment of sheet metal hot path component of SIEMENS make Gas Turbine model no. V94.2 or higher version.

The bidder at his option can also outsource any of the activities required for refurbishment of sheet metal hot path components subject to the condition that the chosen outsourcing agency by the bidder also have the necessary technology for refurbishment of sheet metal hot path components of SIEMENS make Gas Turbine model no. V94.2 or higher version.

OR

- 6.1.3: The bidder can be a licensee or authorized agent of Gas Turbine Original Equipment Manufacturer (OEM). In such case, the bidder can be considered qualified based on the experience of his Principal who meet the requirement mentioned at Clause 6.1.1 and Clause 6.1.2 mentioned above.
- 6.1.4 The bidder should have successfully executed any one of the following "Similar work" within preceding seven (07) years prior to the date of Techno-Commercial bid opening, in any of the following manner:
 - A. One (1) order having executed value not less than Rs. 77 Lakh

OR

B. Two (2) orders having executed value not less than Rs. 48 Lakh each

OR

C. Three (3) orders having executed value not less than Rs. 39 Lakh each

Notes for Technical Criteria:

1. Similar Work Means "Refurbishment of V94.2 Siemens Gas Turbine or Higher Version".

- In case bidding is done by the Licensee or Authorized agent of 'Gas Turbine original Equipment Manufacturer' (OEM), evaluation of the similar work executed as per clause 6.1.4 can be done on the basis of credential of the principals of Licensee or Authorized agent.
- The word "Executed" mentioned above means that the bidder should have achieved the criteria specified above, even if the total contract is started earlier and/or is not completed/closed.
- In case of orders under execution, the value of work executed prior to the date of Techno-Commercial bid opening duly certified by bidder's client shall be considered acceptable.
- 5. Reference work executed by the bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by owner specifying the scope of work executed by the sub-contractor in support of qualifying requirements.
- For arriving at the executed value of work specified above, basic amount only shall be considered. In case contract is inclusive of taxes, bidder should provide the break – up of basic value and taxes.

6.2. Financial criteria:

- 6.2.1. The Average Annual Turnover of the Bidder, should not be less than **Rs. 97 Lakh** (Rupees Ninety-Seven lakh only) during the preceding three (3) completed financial years as on the date of Techno-Commercial bid opening.
- 6.2.2. In case the bidder does not satisfy the financial criteria, stipulated at Cl. 6.2.1 above on its own, its Holding Company would be required to meet the stipulated turnover requirements at Cl. 6.2.1 above, provided that the net worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid-up share capital of the Holding Company. In such an event, the bidder would be required to furnish along with its Techno-Commercial bid, a Letter of Undertaking from the Holding Company, supported by Board Resolution, as per the format enclosed in the bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the bidder in case of award.
- 6.2.3. In case the bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.
 - Copies of the unaudited unconsolidated financial statements of the bidder along with copies of the Audited consolidated financial statements of its Holding Company.

- Certificate from the CEO/CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the Consolidated Annual Report of the company.
- 6.2.4. In cases where audited results for the last preceding financial year as on the date of Techno-Commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a Certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of Techno-Commercial bid opening and the Certificate from the practicing Chartered Accountant certifying the financial parameters is not available.

Notes for 6.2;

- i. Other income shall not be considered for arriving at annual turnover.
- ii. "Holding Company" and "Subsidiary Company" shall have the meaning ascribed to them as per Companies Act of India, in vogue.
- iii. Net worth means the sum total of the paid up share capital and free reserves. Free reserve means all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further, any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus.
- 7. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators / associates/ subsidiaries / group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
- 8. The reference works whose details have been declared in their bid shall only be considered to ascertain the bidder's compliance to the specified qualifying Requirement (QR). The Employer at its discretion may seek any clarification and/or documentary evidence only for the reference works as mentioned above. However, no change or substitution of the reference works by new/additional plant for conforming to the specified qualifying Requirement shall be sought, offered or permitted".
- 9. 'Class-I local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

10. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

- 11. NTPC reserves the right to reject any or all bids or cancel/withdraw the NIT for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
- 12. Issuance of bid documents to any bidder shall not construe that such bidder is considered to be qualified. Bids shall be submitted online and opened at the address given below in the presence of Bidder's representatives who choose to attend the bid opening.
- 13. The bidding document is available online. A complete set of Bidding Documents may be downloaded by any interested Bidder from the NTPC tender website <u>https://eprocurentpc.nic.in</u>. The Bidder would be required to register on the website.

First time users are required to register themselves on NTPC tender website (<u>https://eprocurentpc.nic.in</u>) after filling up the required details.
