NTPC Ltd invites "Expression of Interest (EOI)" for assessing market response for short listing of Purchasers/Agencies for further course of action such as Long term tie up/ MOUs/ Tendering or any combination of the said three options, for the selling of "Gypsum" from NTPC Telangana. The interested parties can also indicate whether they are Gypsum wall board manufacturers or Glass fiber reinforced gypsum panel manufacturers or cement manufacturing enterprise or any other manufacturing/utility industry unit using gypsum. The total amount of Gypsum produced can be given to such interested companies/parties on long term basis/MOUs/Agreement.

The quality of Gypsum procured from NTPC Telangana shall be 85 - 90% pure with Moisture content \leq 10% and Chloride content \leq 100 ppm (dry). Quantity of Gypsum produced will be approximately 1000 MT/day considering both units operating on full load.

1. INTRODUCTION

NTPC Limited is constructing Telangana Super Thermal Power Plant Phase-I (2x800 MW) at Ramagundam in Peddapalli District of Telangana State. Both the units of the project are under advance stage of implementation and are anticipated for declaration for commercial operation in the month of March 2022 (Unit-I) and September 2022 (Unit-II). The Flue Gas De-sulphurisation (FGD) system is also progressing and it is expected to start operation along with the respective COD of Units of Telangana Project.

2. INTENT OF THE EXPRESSION OF INTEREST (EOI)

NTPC Telangana invites “Expression of Interest (EOI)” for assessing market response for short listing of Purchasers/Agencies for further course of actions such as Long term tie up/MOUs/Tendering or any combination of the said three options, for the selling of ‘Gypsum’ from FGD plant of NTPC Telangana. The interested parties can also indicate whether they are Gypsum wall board manufacturers or Glass fiber reinforced gypsum (GFRG) panel manufacturers or cement manufacturing enterprise or any other manufacturing industry unit using gypsum. In such a case, the total amount of Gypsum produced can be given to such companies/parties on long term basis/MOUs/Agreement. It may be pertinent to note that, the Quality of Gypsum procured from Telangana Project **shall be of purity 85 - 90%, Moisture: <= 10 %, Chloride: <= 100 ppm(dry). Quantity of Gypsum produced will be of the approximately 1000 MT/day considering both units operating on full load.**

4. SCOPE OF THE EXPRESSION OF INTEREST (EOI)

The scope of EOI is for sale/ off take of Gypsum from FGD plant NTPC Telangana.

5. TERMS AND CONDITIONS OF THE EXPRESSION OF INTEREST (EOI)

- i. The first and second Unit of NTPC Telangana is likely to be commissioned in March 2022 and September 2022 respectively. Agencies/vendor should plan for the off take of Gypsum accordingly.
- ii. The interested Purchasers/ Agencies shall have to make their own arrangement for transportation of Gypsum from NTPC Telangana Project.
- iii. NTPC Telangana reserves the right to assess the capacity/ capability of the applicant and viability of proposal, based on verification of documents and if required, cross verification for establishment of the capable applicant(s).
- iv. NTPC Telangana reserves the right to accept or reject any or all applications, cancel/withdraw the EOI process without assigning any reason whatsoever in case situation arises, and in such a case no applicant shall have any claim arising out of such action.
- v. The interested Purchasers/ Agencies shall be responsible for all the costs associated related to the preparation of the response and participation related with this EOI, NTPC shall not be responsible in any way for such costs, regardless of the conduct or outcome of this short-listing/ selection process
- vi. Interested Purchasers/ Agencies shall ensure proper care and constant vigil of transportation activities for any damages to any existing properties, which may result in Environmental hazards in any way, in case of award.
