4.0 Brief Scope of Work and other Specific details:

Supply & Installation of 15Ltr. 5 Star, 230VAC horizontal type storage electric geyser with accessories for Kabir House & Tagore Hostel at NTPC-PMI, Sector-16A, Noida.

5.0 Downloading / Issuance of bidding documents to any bidder shall not construe that bidder is considered qualified.

6.0 'Class-I local suppliers' and '~~Class-II local suppliers~~' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

7.0 Qualifying Requirements for Bidders:

7.1 The bidder should have successfully completed/ executed any one of the following works in preceding seven (07) years as on the date of techno-commercial bid opening, which includes Operation & Maintenance work of Electrical systems or Maintenance of the civil work or renovation work in the residential flats or supplied & installed of geysers in Govt. Organization / Public Sector / Private Sector Companies / Institutions in India:

a) One contract having executed value not less than ₹21,50,300.00.

OR

b) Two contracts having executed value not less than ₹13,43,900.00 each.

OR

c) Three contracts having executed value not less than ₹10,75,100.00 each.

The work "executed" means the bidder should have achieved the criteria specified in the QR, even if the total contract is not completed / closed.

In case of contracts under execution as on date of bid opening, the value of work completed till the date of bid opening will be considered provided the value of executed work is certified by the employer.

7.2 The average annual turnover of the bidder, in the preceding three (3) financial years as on the date of Techno-Commercial bid opening shall not be less than ₹26,87,900.00.

Note:

- While computing the turnover other income shall not be considered.
- In cases where audited results for the last financial year as on the date of Techno commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, bidder is not able to submit the certificate from practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificate from the practicing Chartered Accountant certifying the financial parameters is not available..

8.0 NTPC reserves the right to reject any or all bids or cancel / withdraw the Notice Inviting Tender [NIT] for the subject package without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
